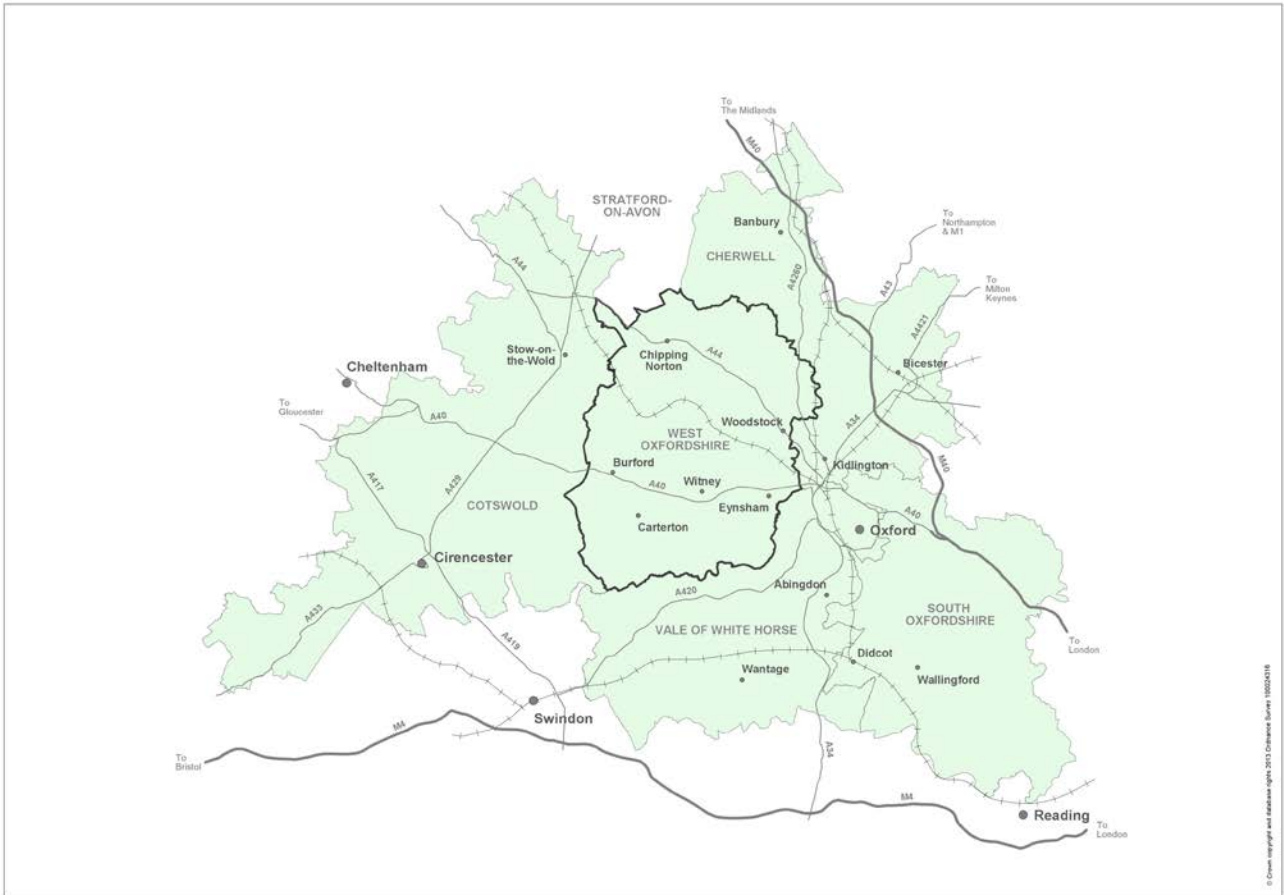


Fig 4.1 – West Oxfordshire Sub-areas and Key Diagram

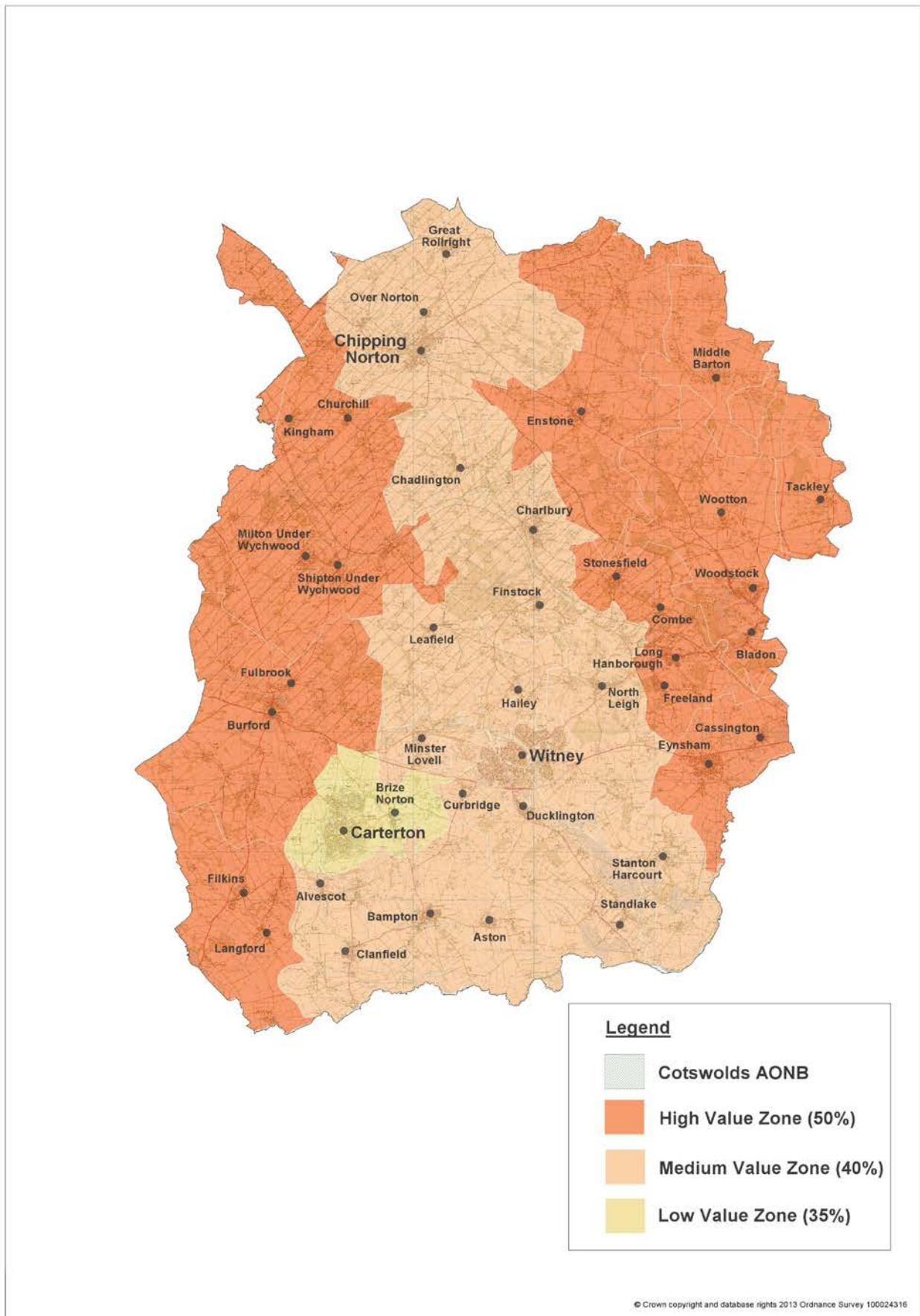


Fig 5.2 – Residential Property Types in Oxfordshire

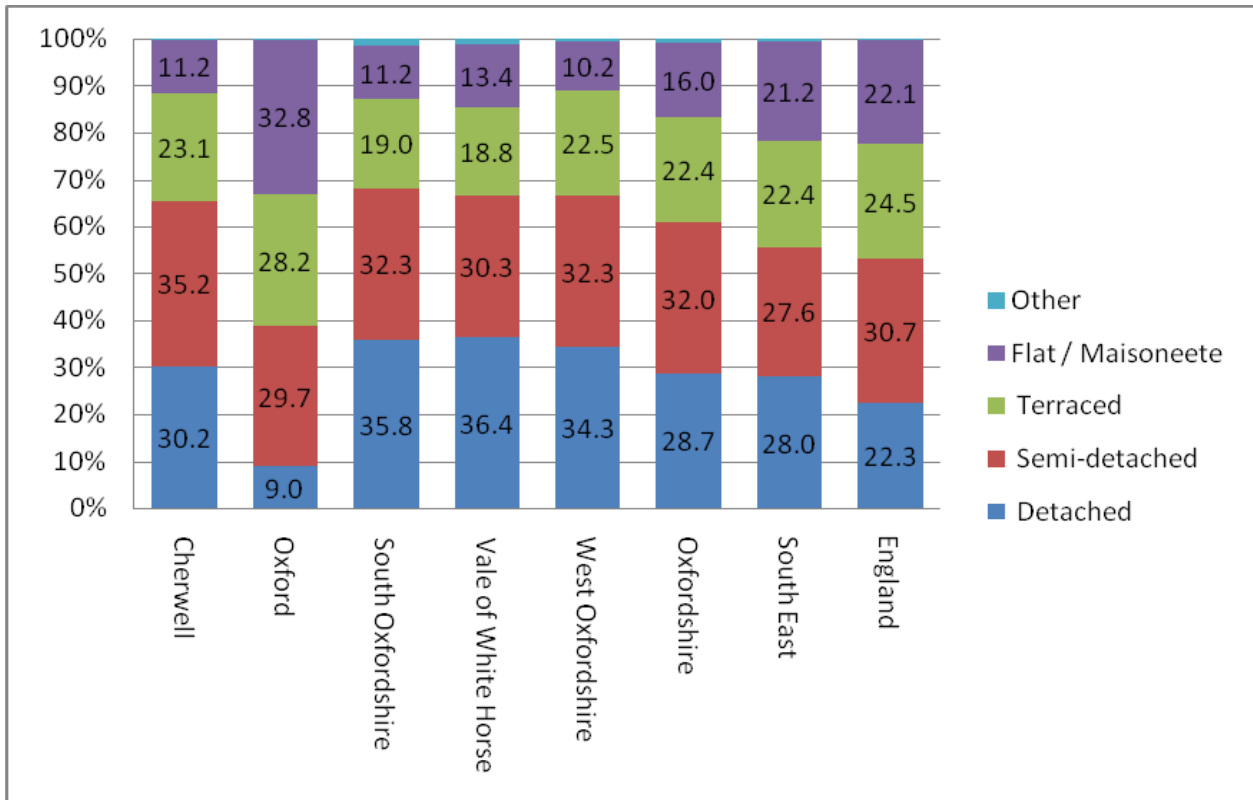
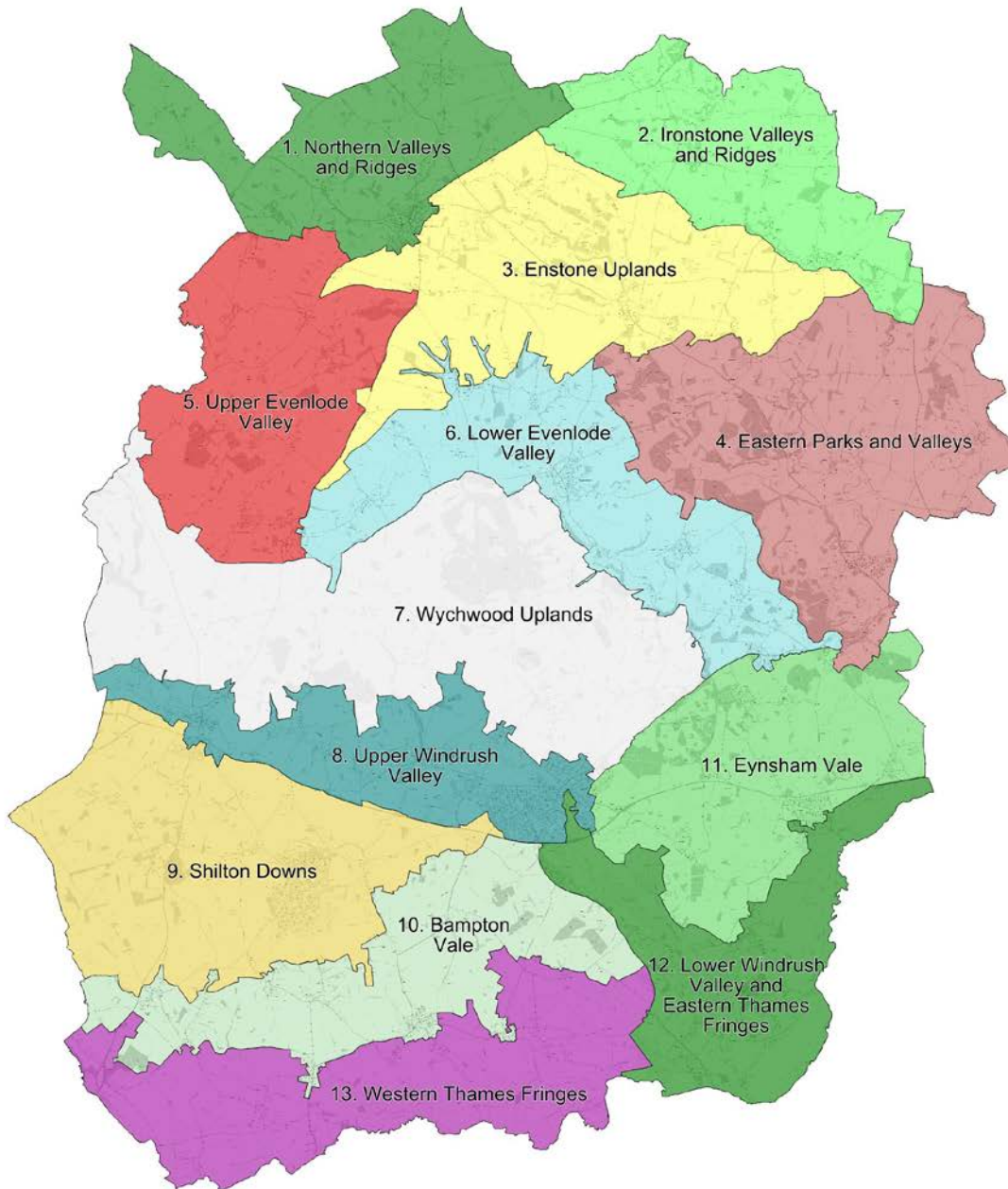


Fig 5.3 – Cuckoowood Farm

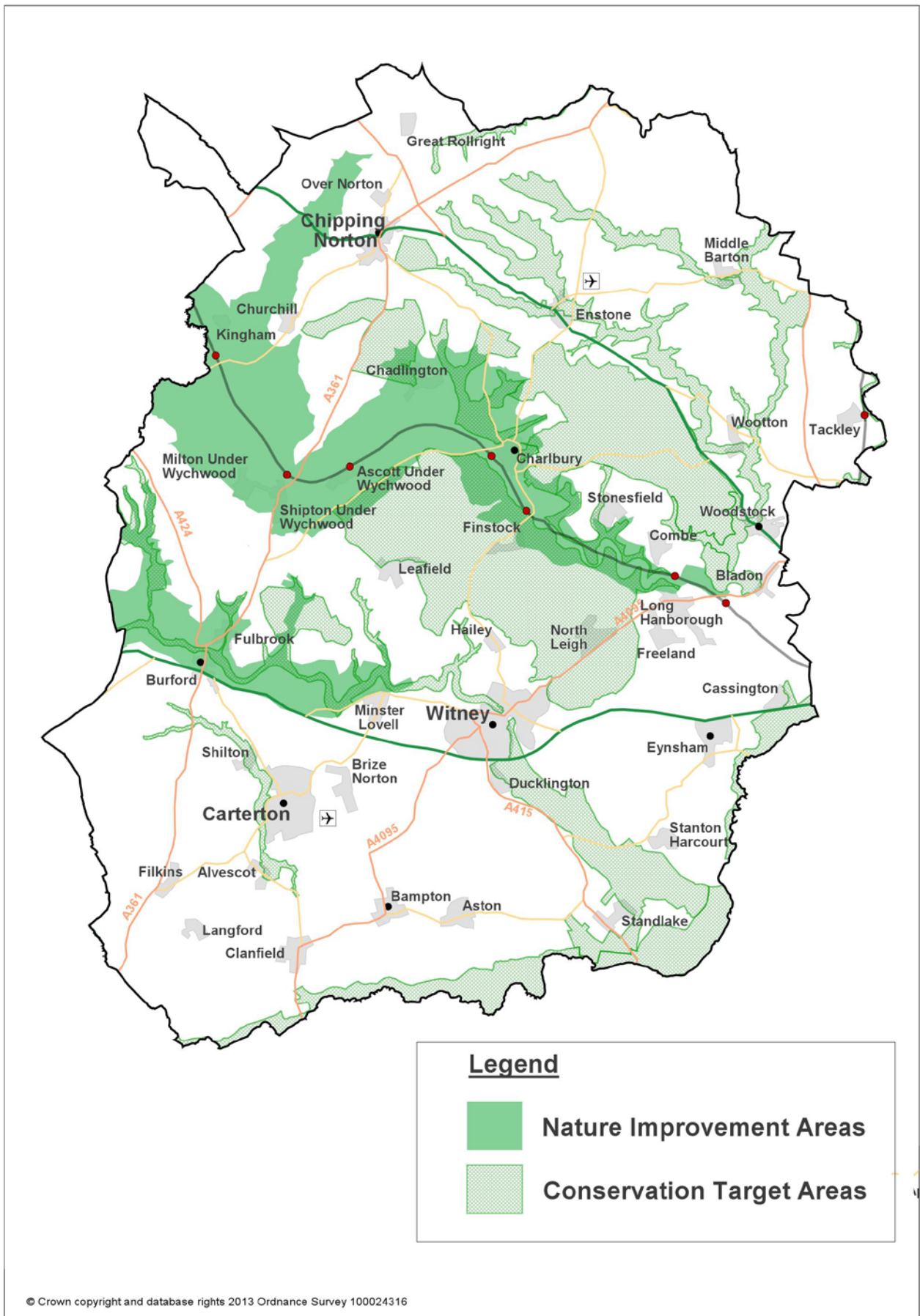


Fig 8.4 – Local Ecological and Geological Networks

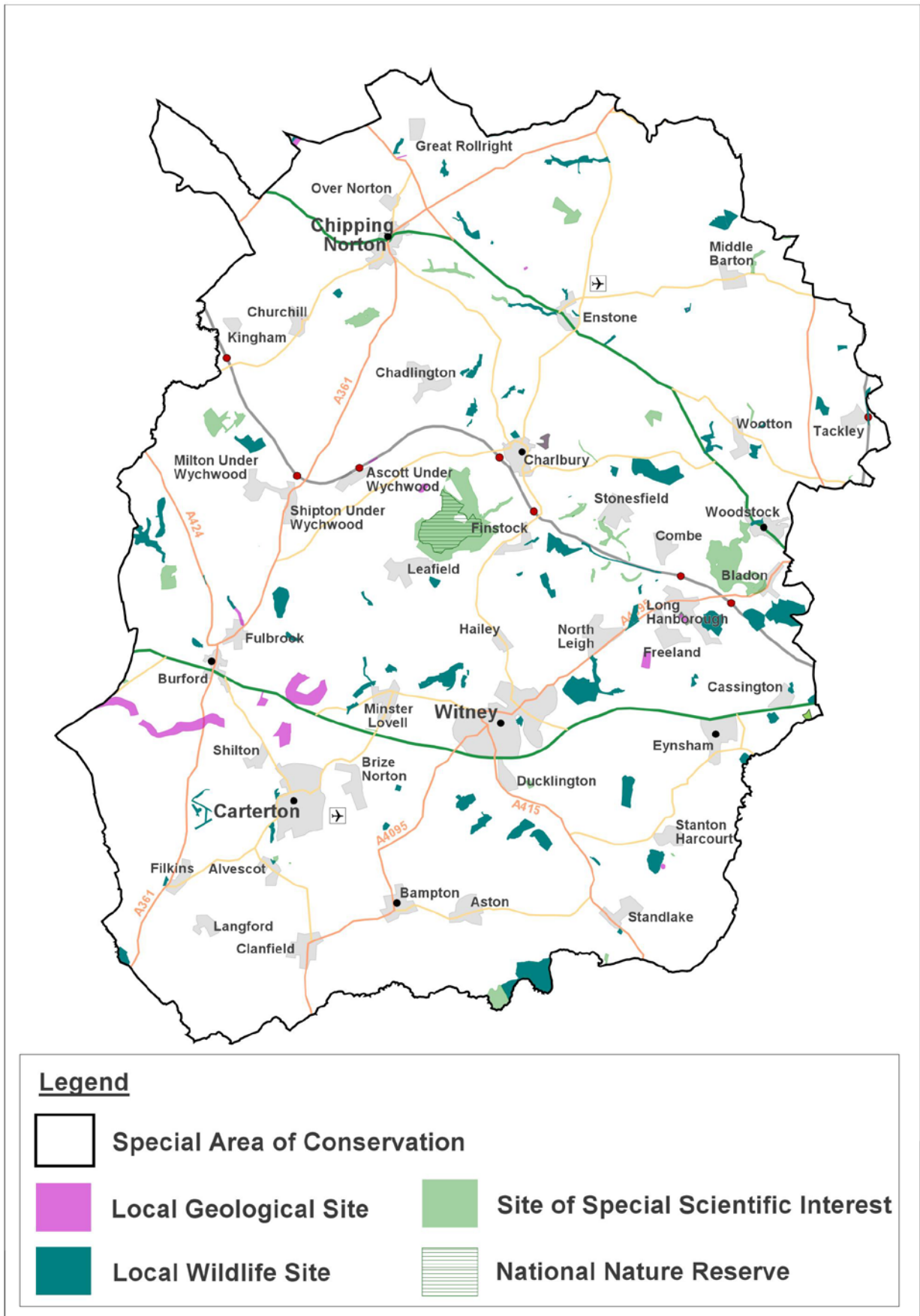


Fig 8.5 – Registered Parks and Gardens of Special Historic Interest

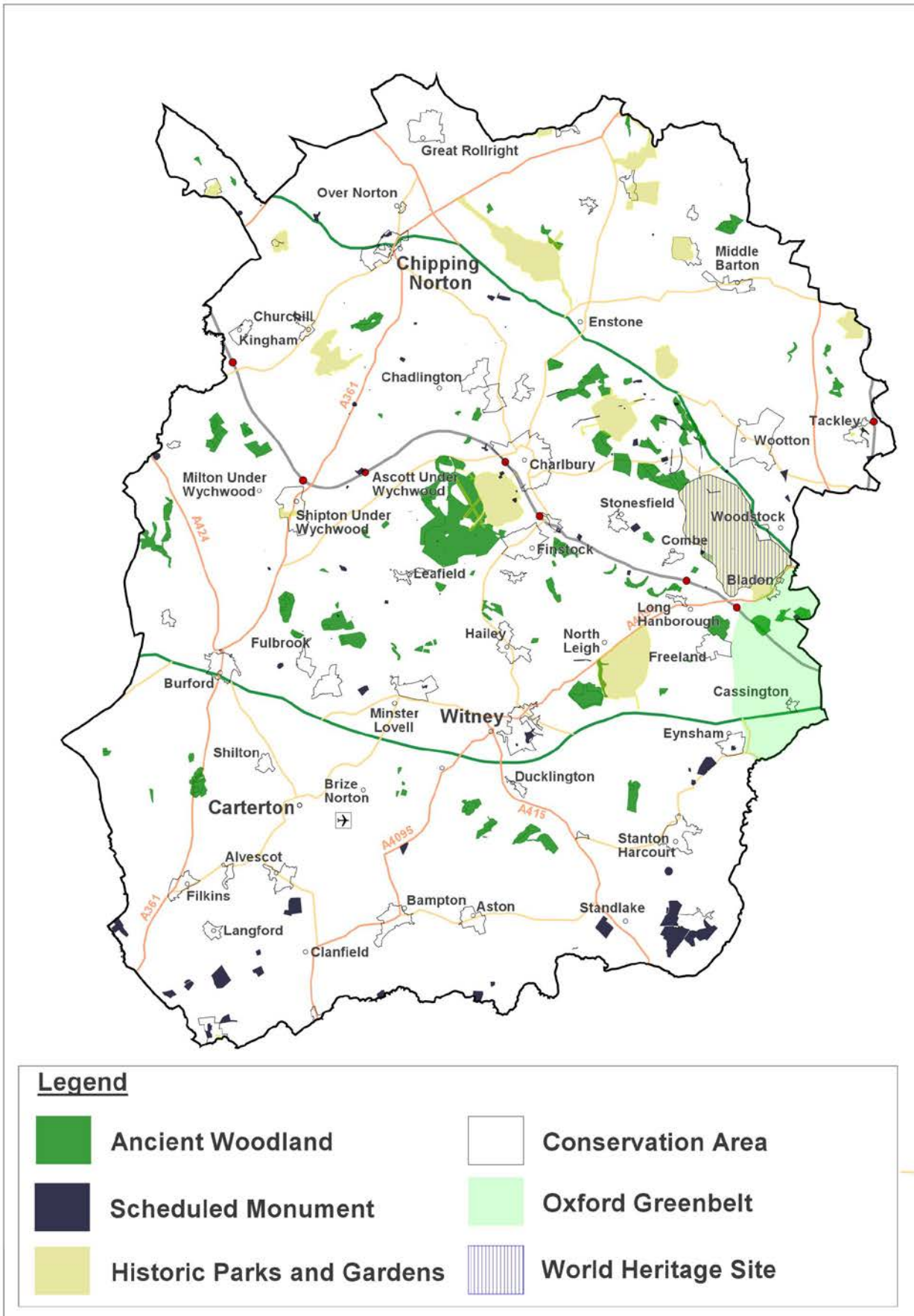


Fig 9.1 – Sub Area Plan

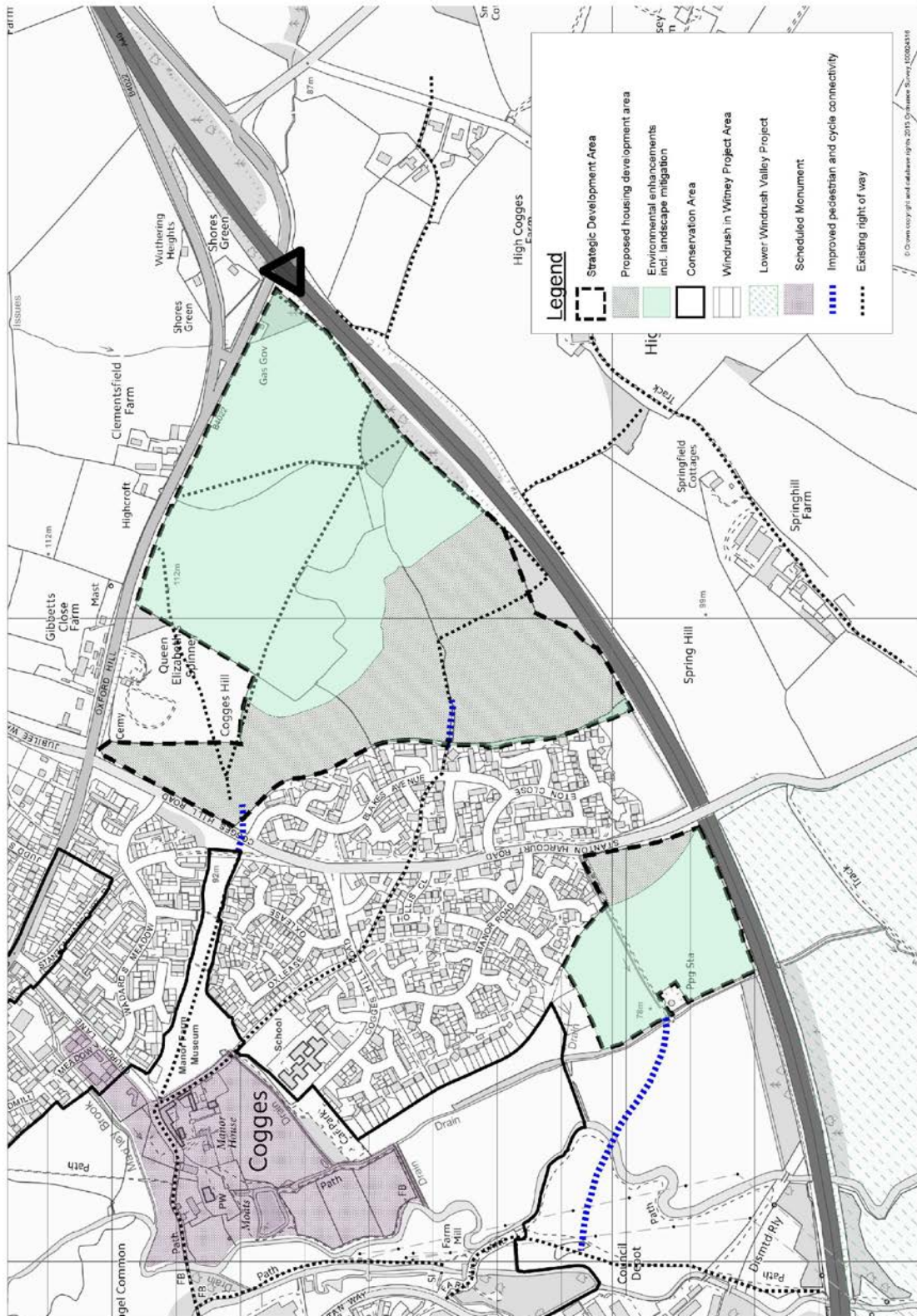


Fig 9.4 – North Witney SDA

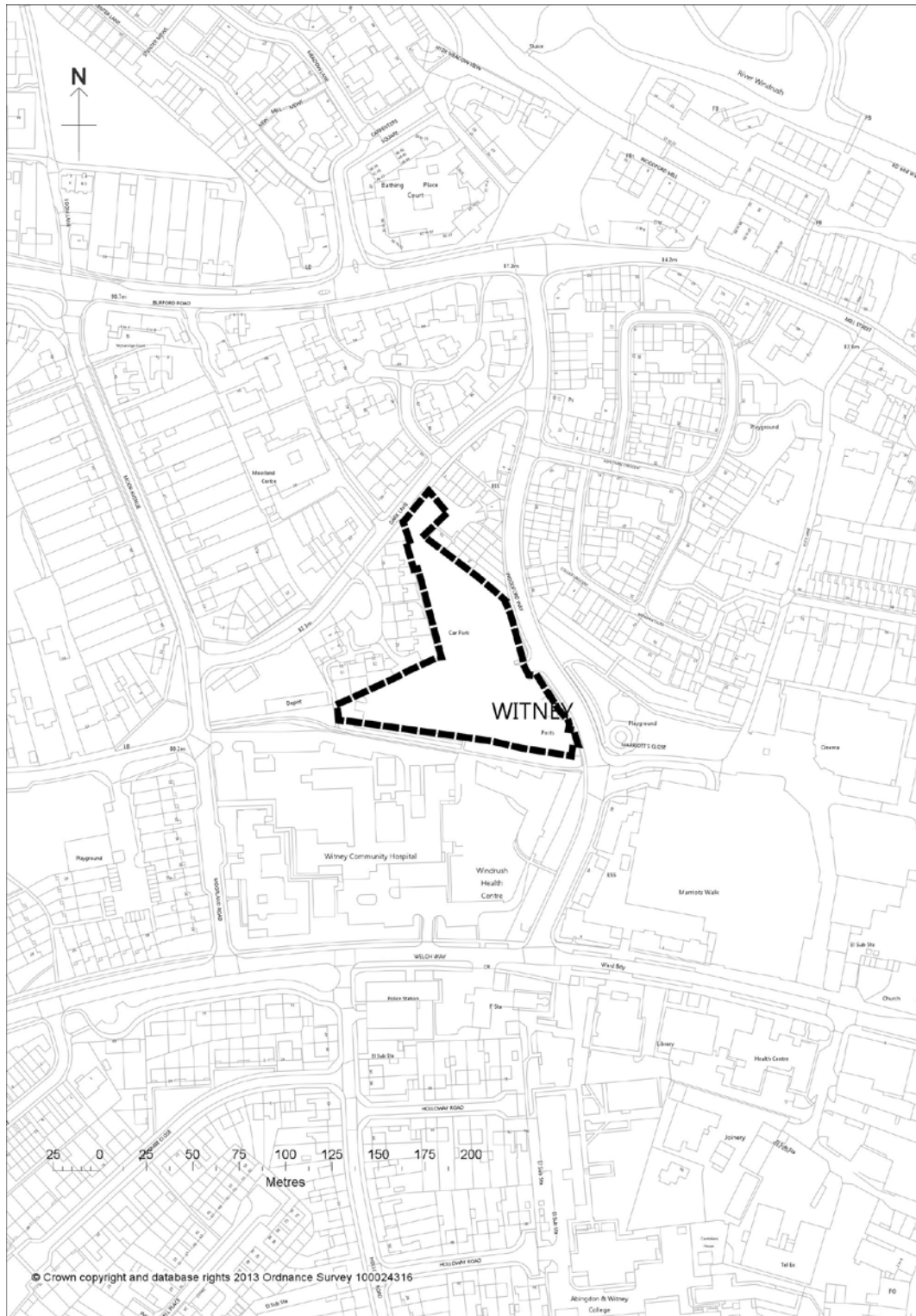


Fig 9.4b – Land west of Minster Lovell

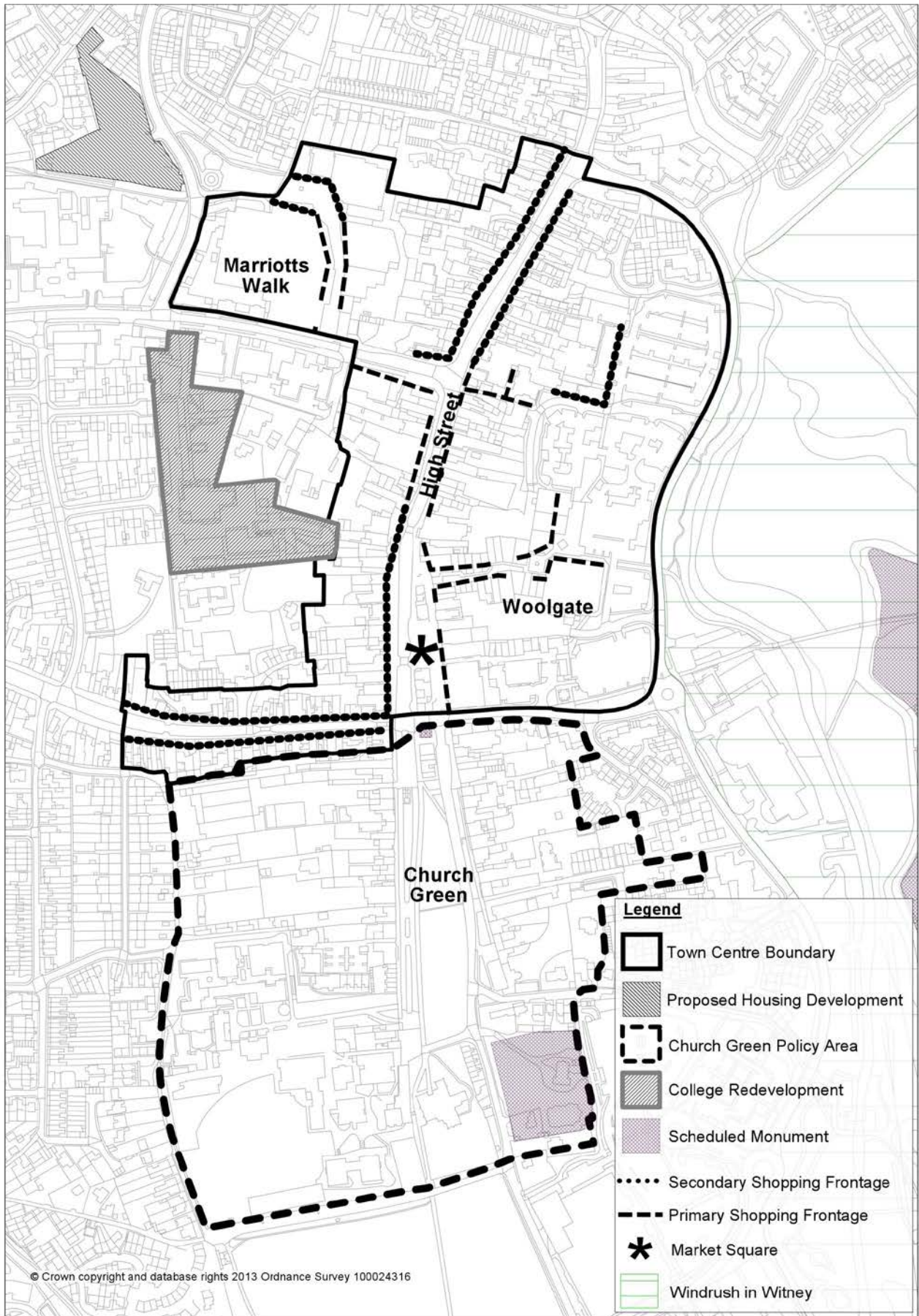


Fig 9.6 – Witney Sub Area Strategy

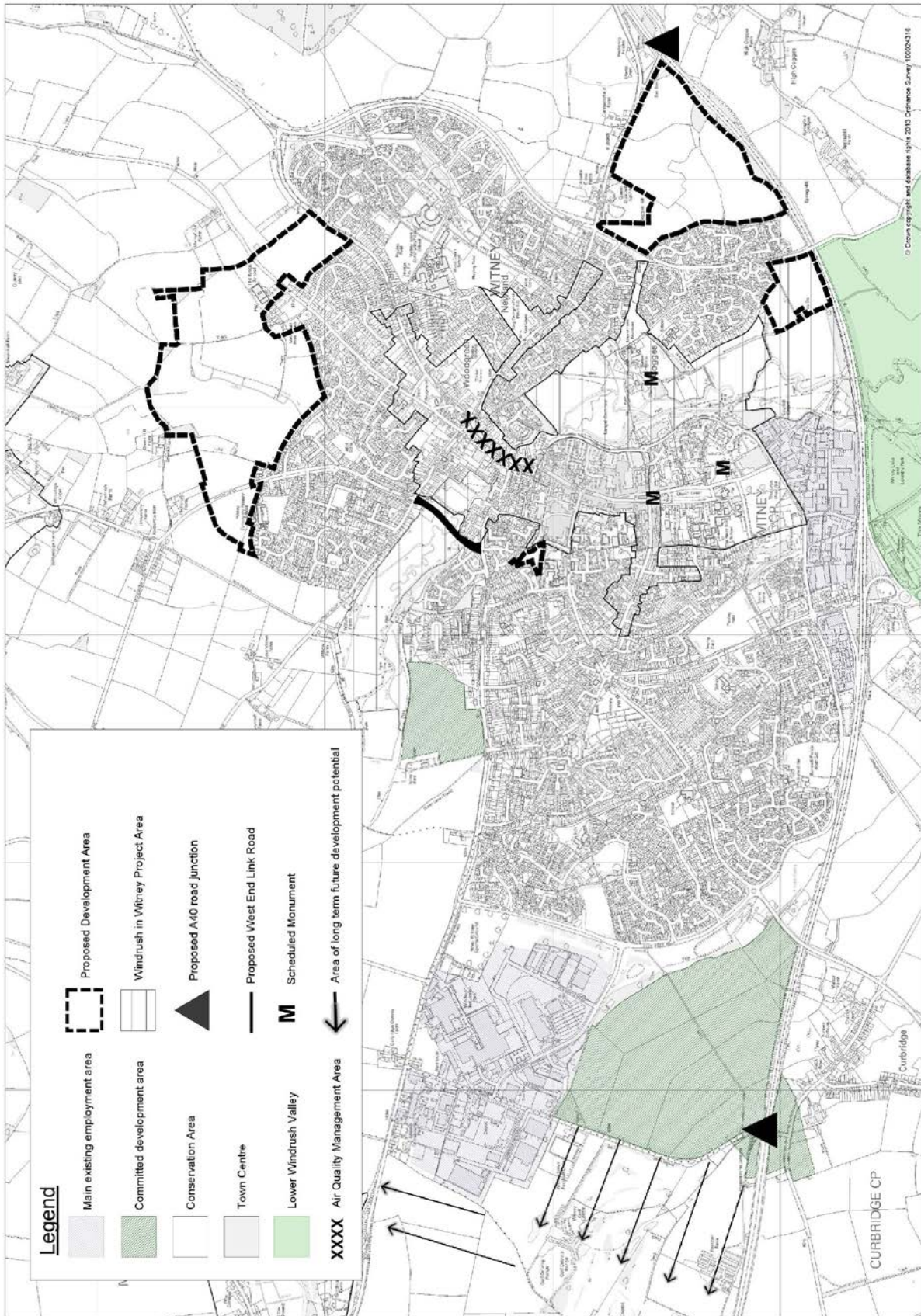
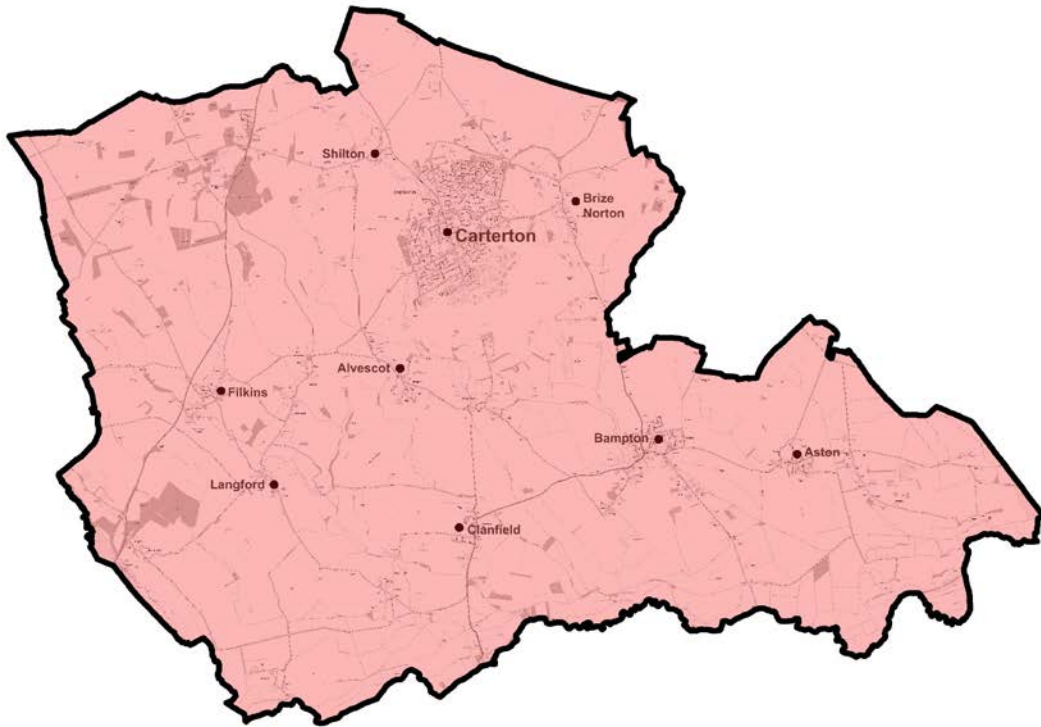


Fig 9.7 – Carterton Sub Area

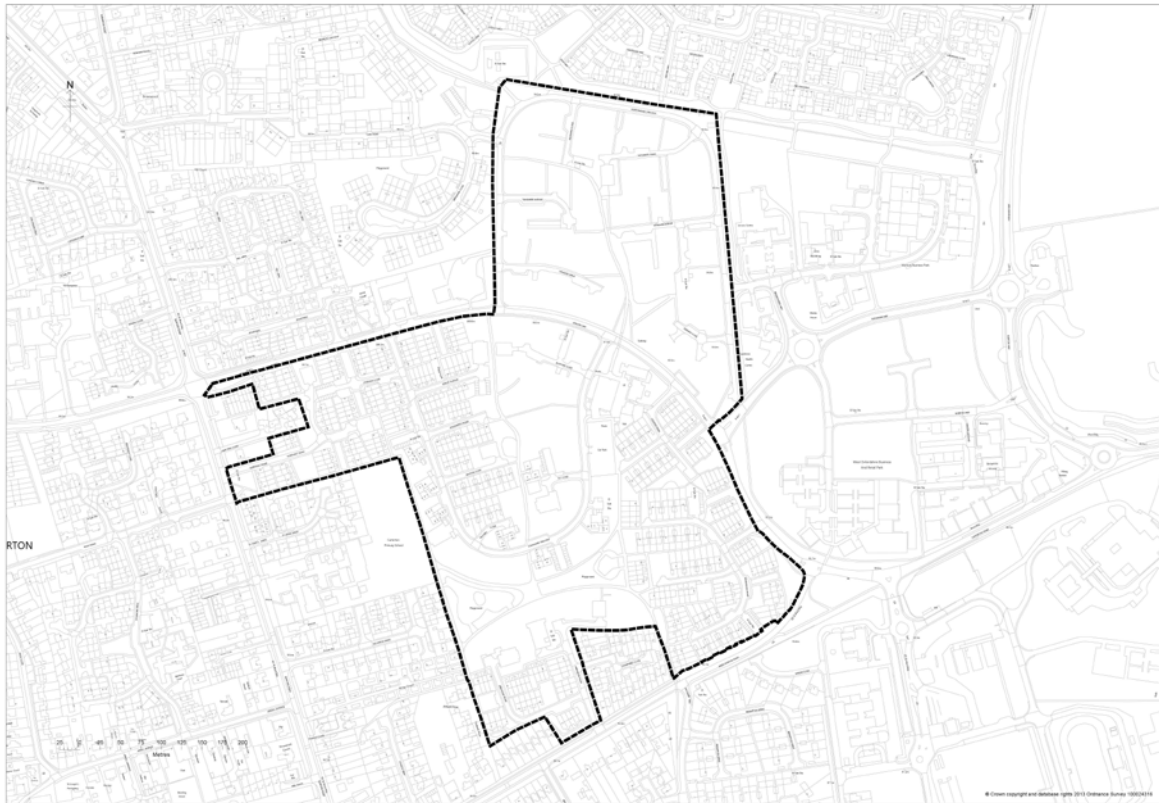


Fig 9.8a – Land at Milestone Road

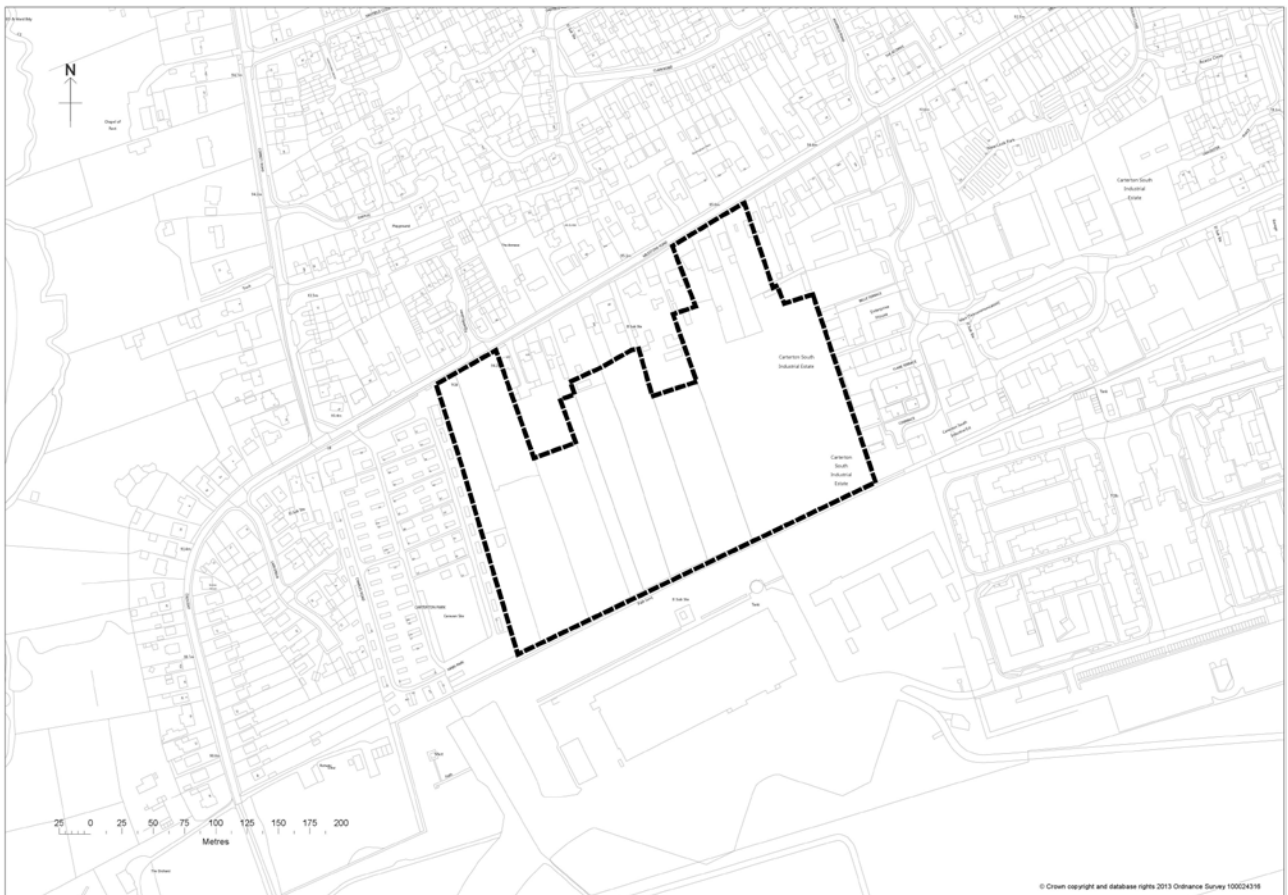


Fig 9.8b – Land at Swinbrook Road

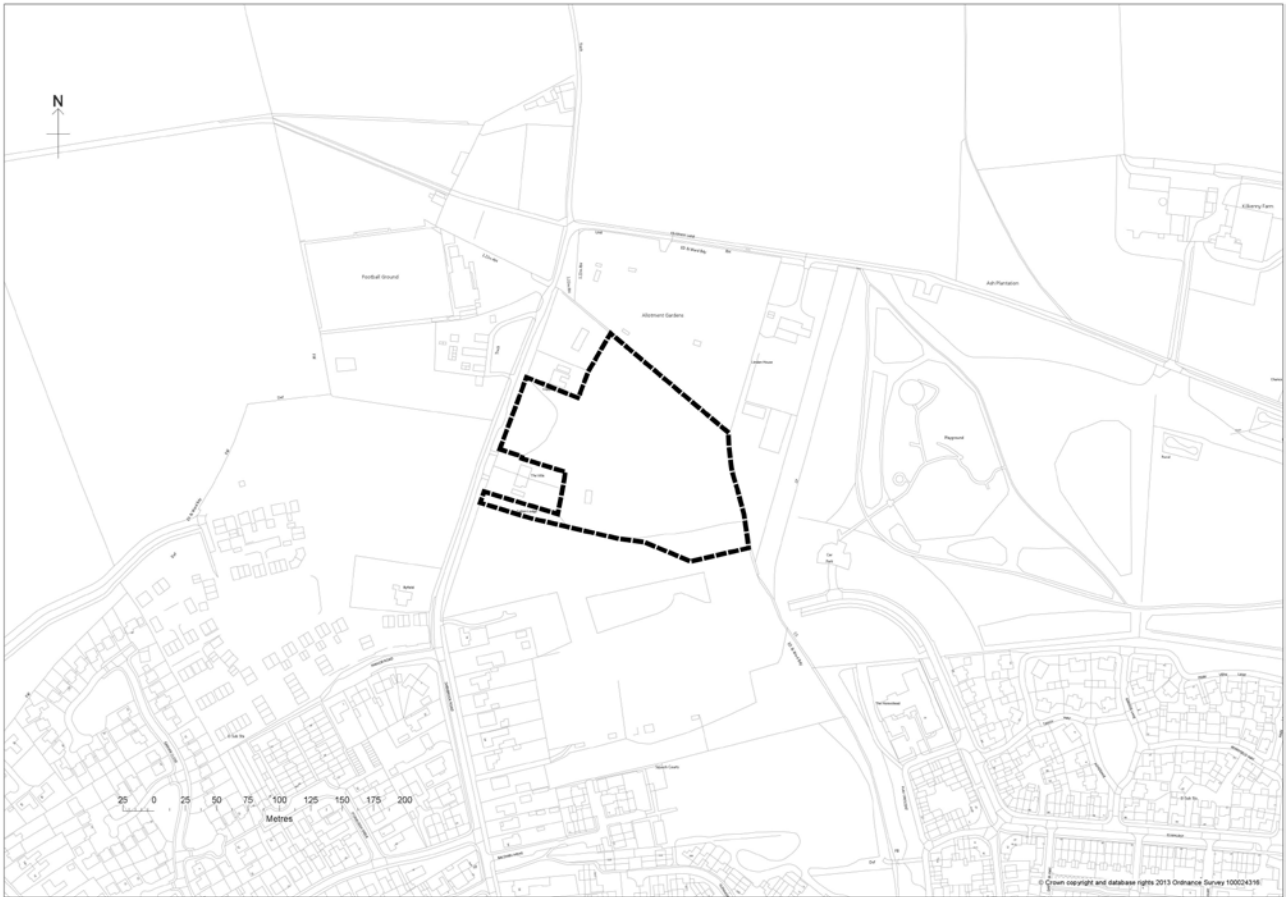


Fig 9.9 – Carterton Town Centre Strategy

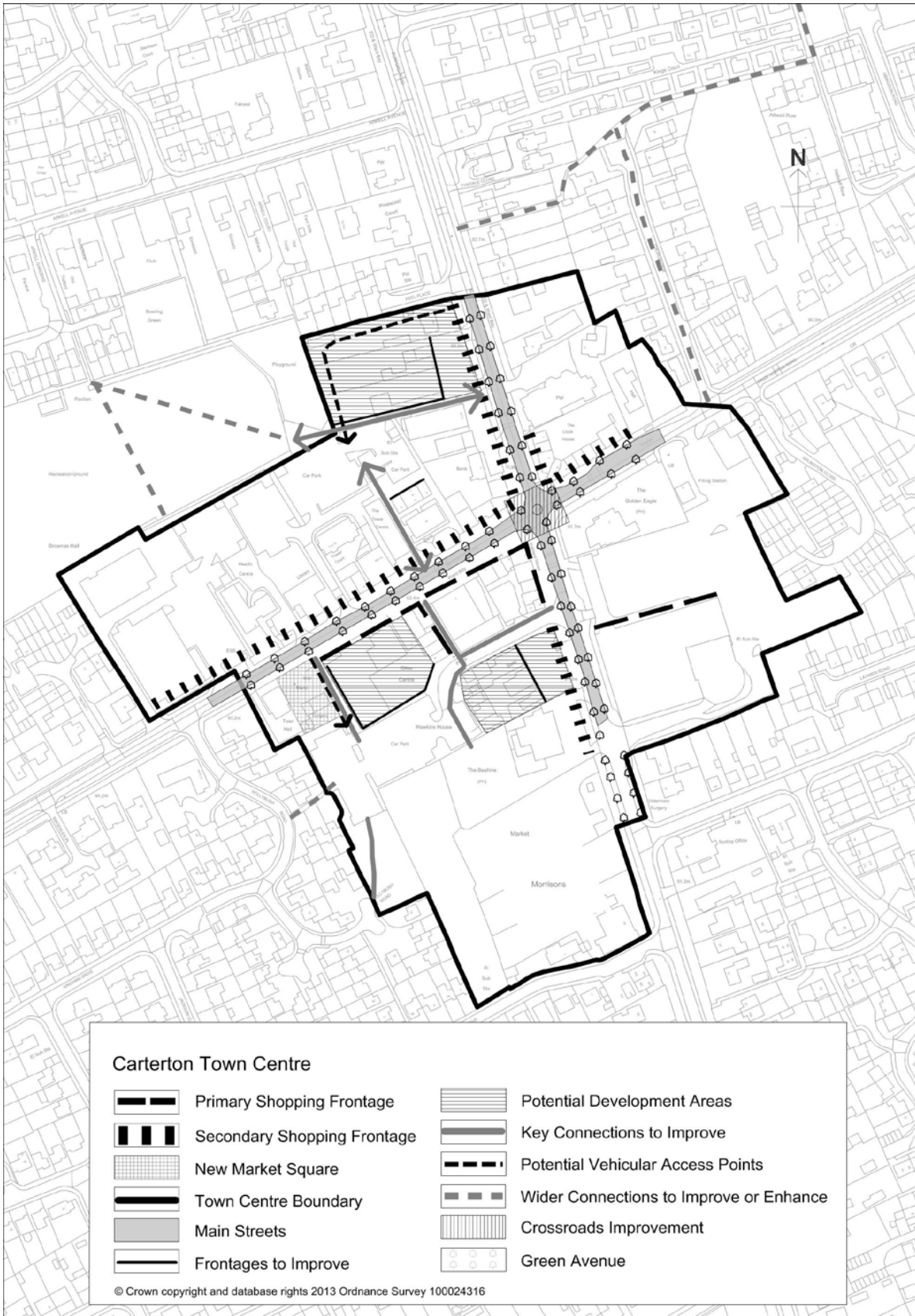


Fig 9.10 – Carterton Sub Area Strategy

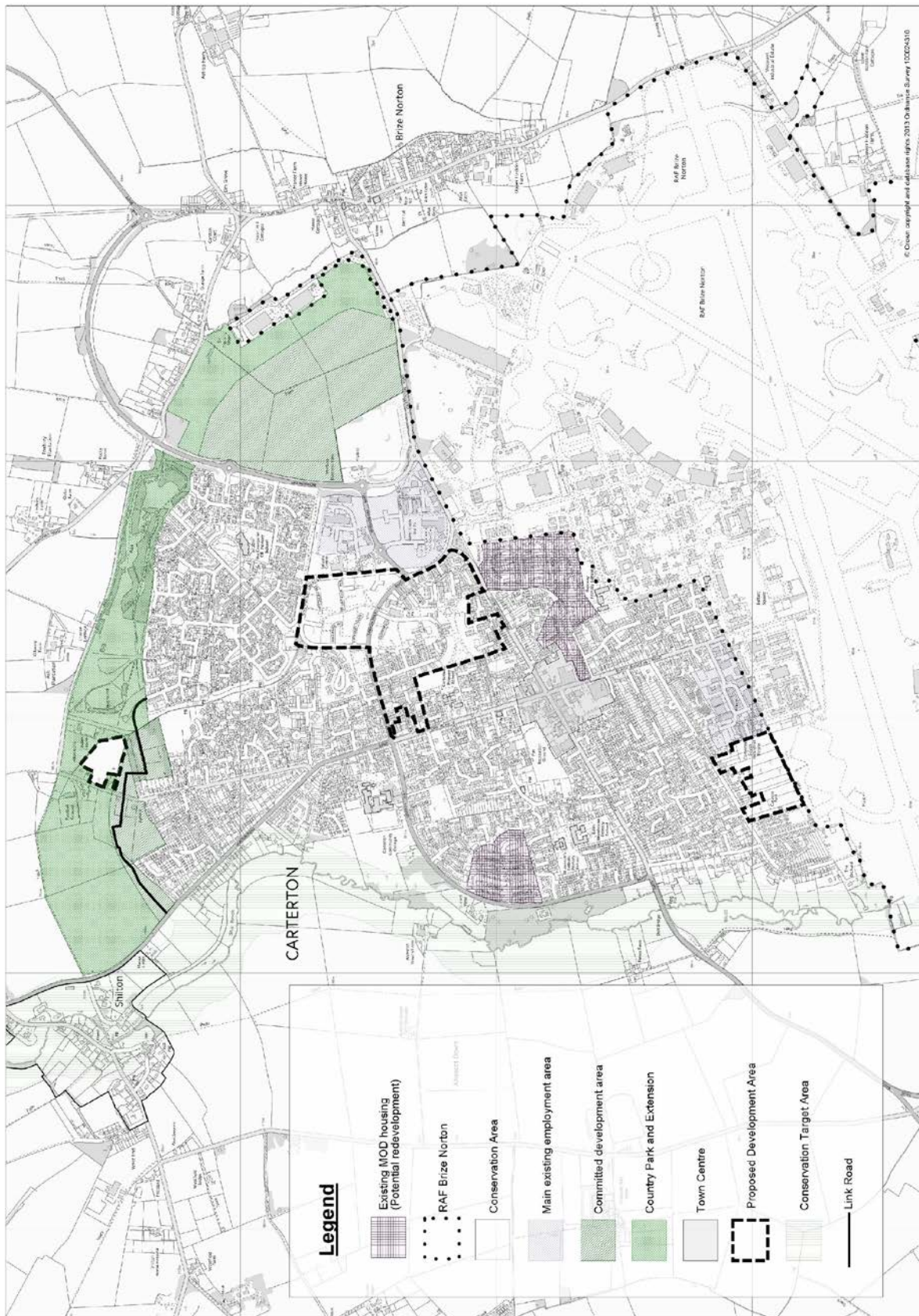
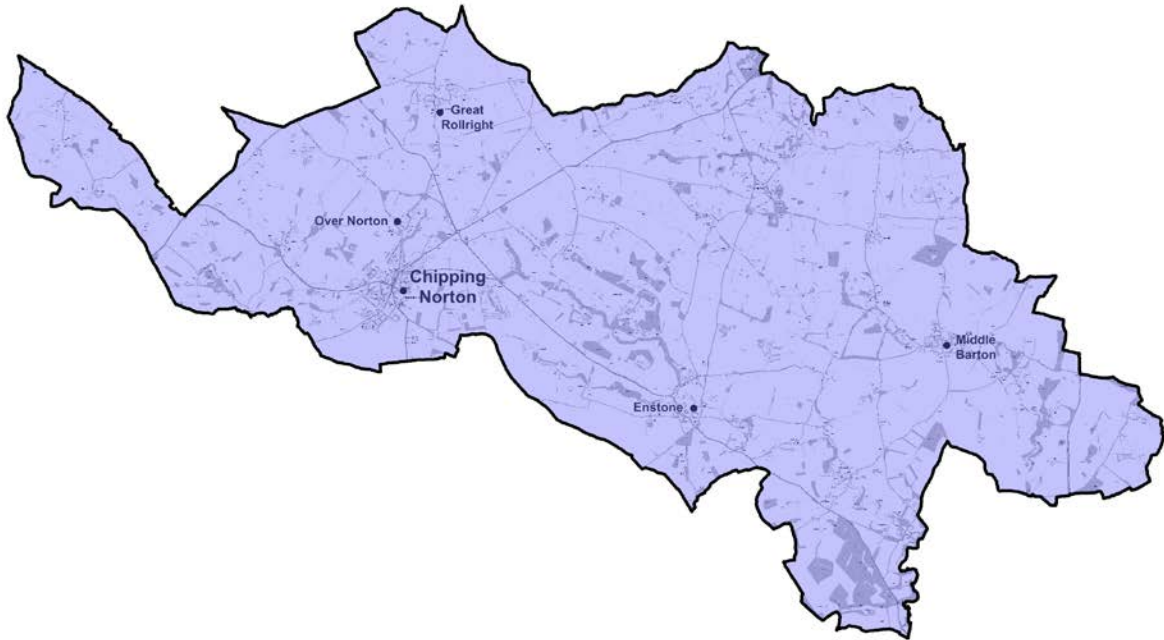


Fig 9.11 – Chipping Norton Sub Area

Fig 9.12 – Land East of Chipping Norton (Tank Farm SDA)

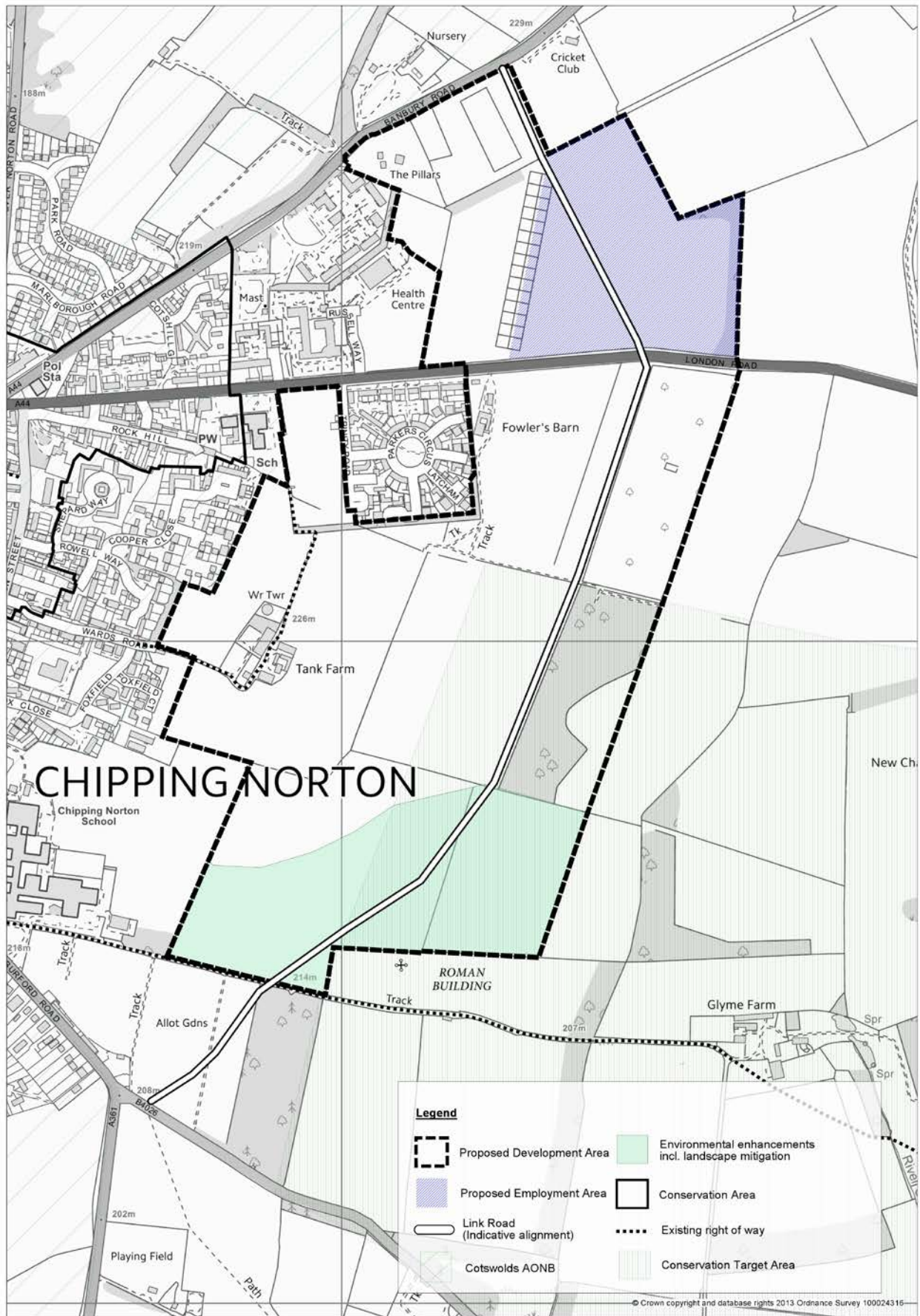


Fig 9.13 – Chipping Norton Town Centre

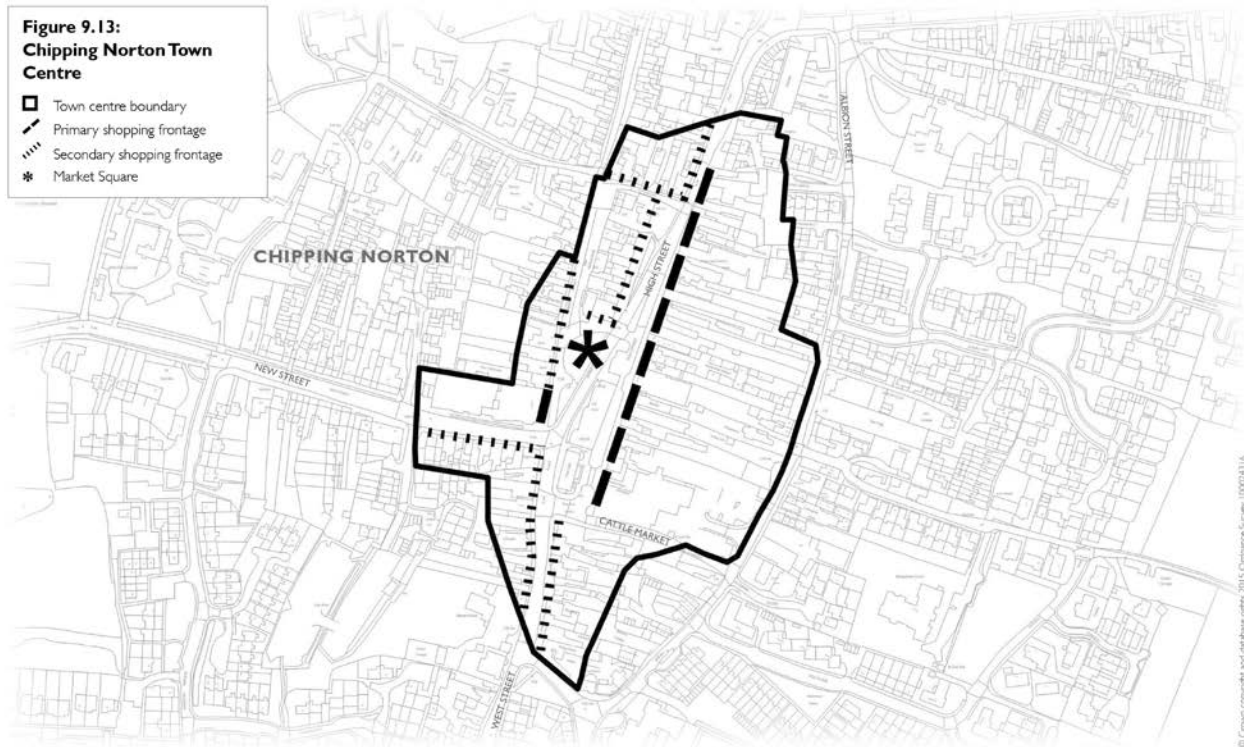


Fig 9.14 – Chipping Norton Sub Area Strategy

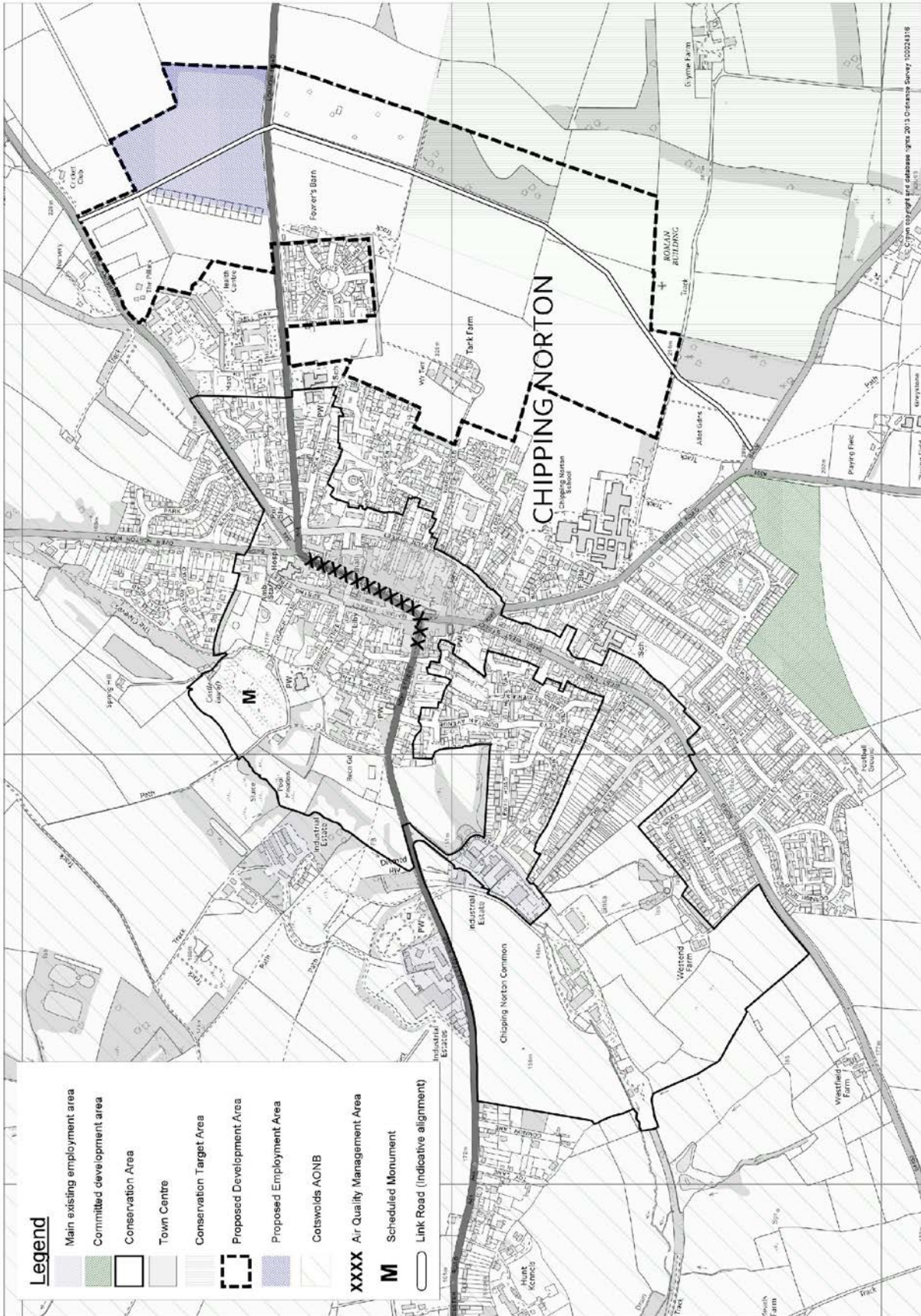
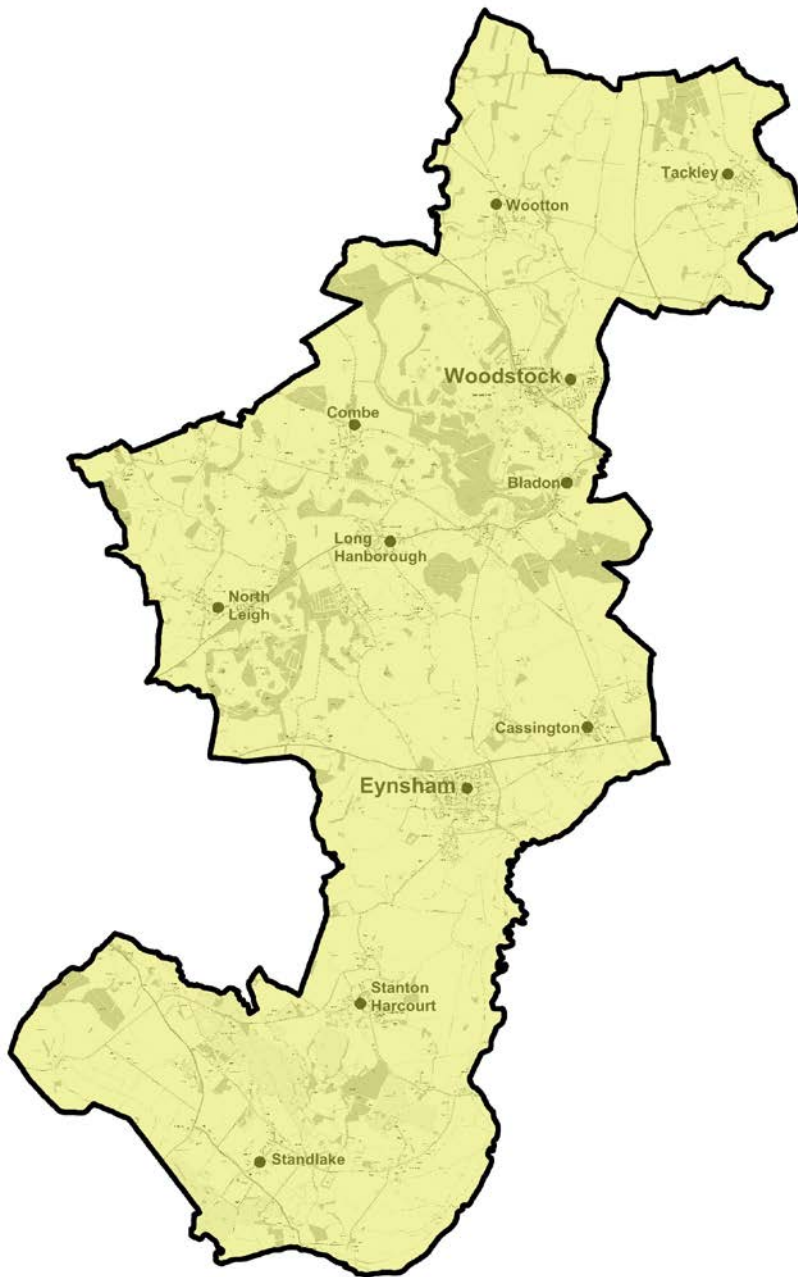


Fig 9.15 – Eynsham Woodstock Sub-Area

Fig 9.15a – Tilgarsley Garden Village SDA

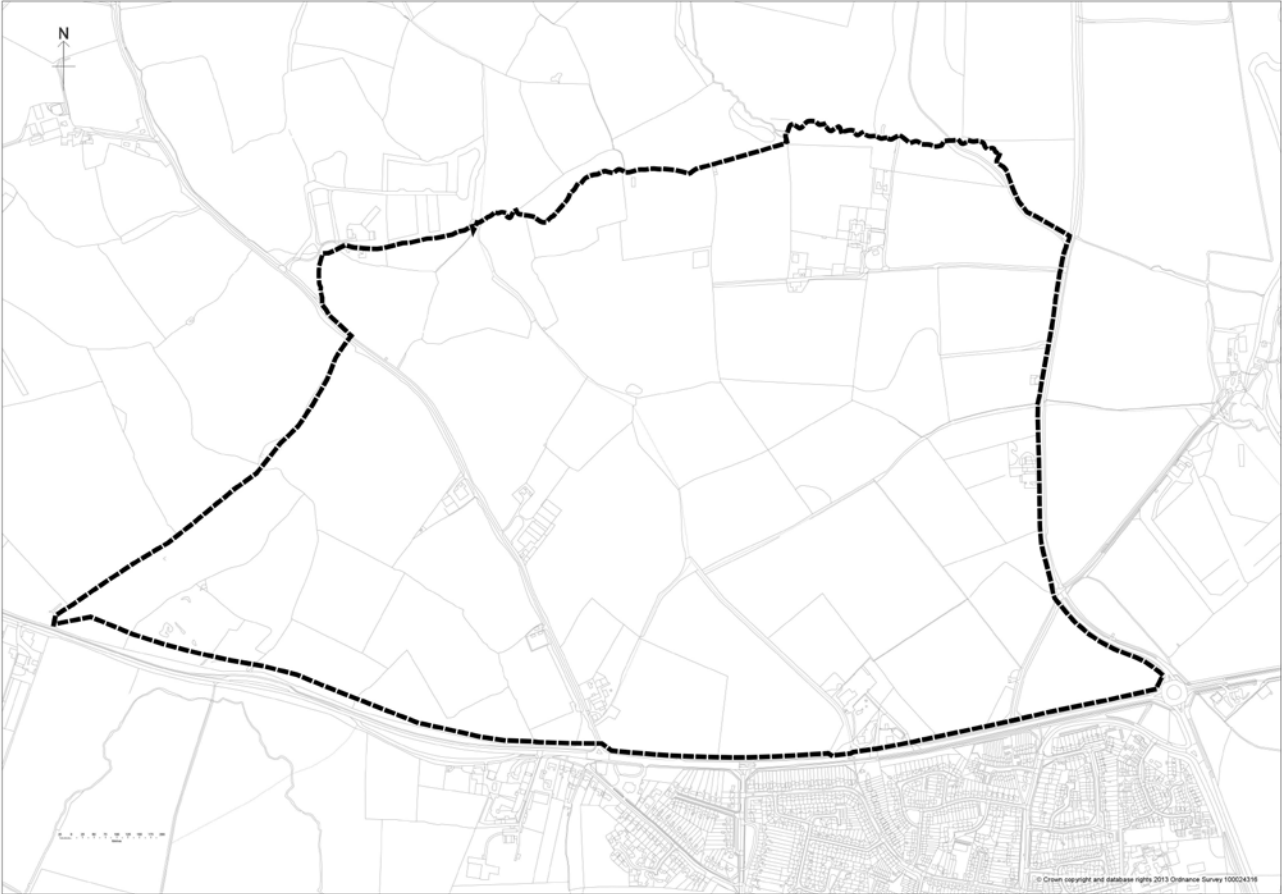


Fig 9.15b – West Eynsham SDA

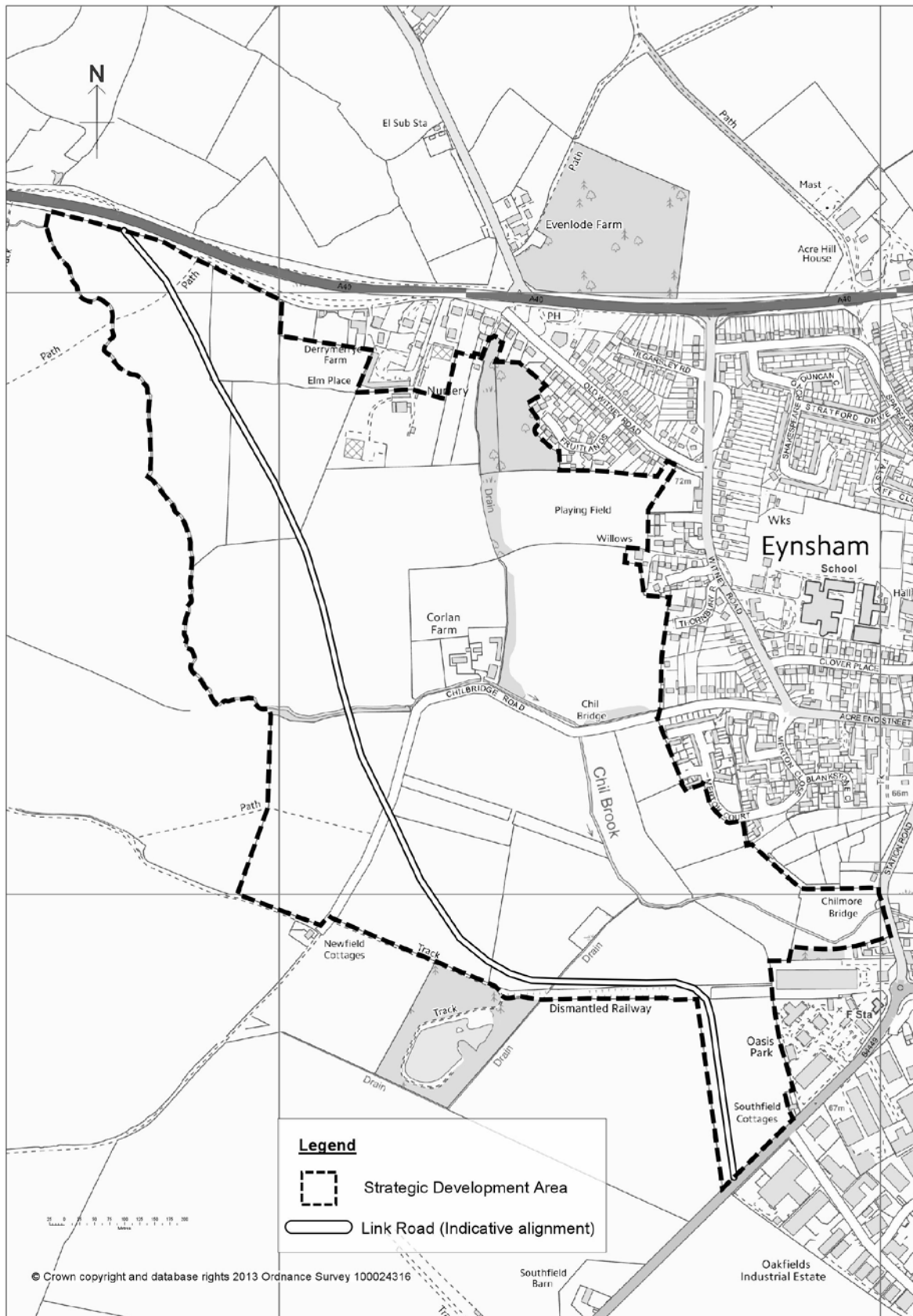


Fig 9.15d – Land north of Hill Rise, Woodstock

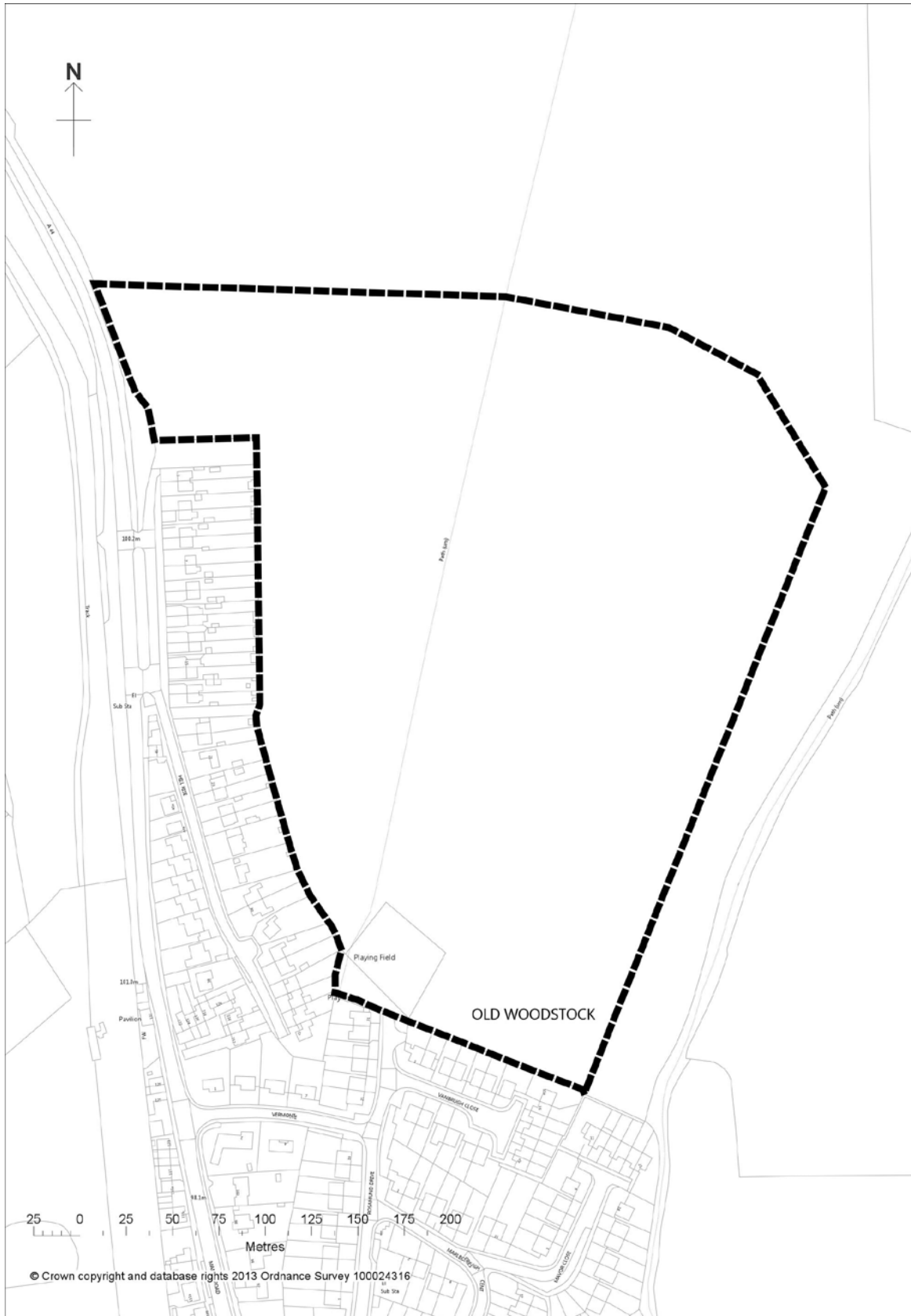


Fig 9.15e – Land north of Banbury Road, Woodstock

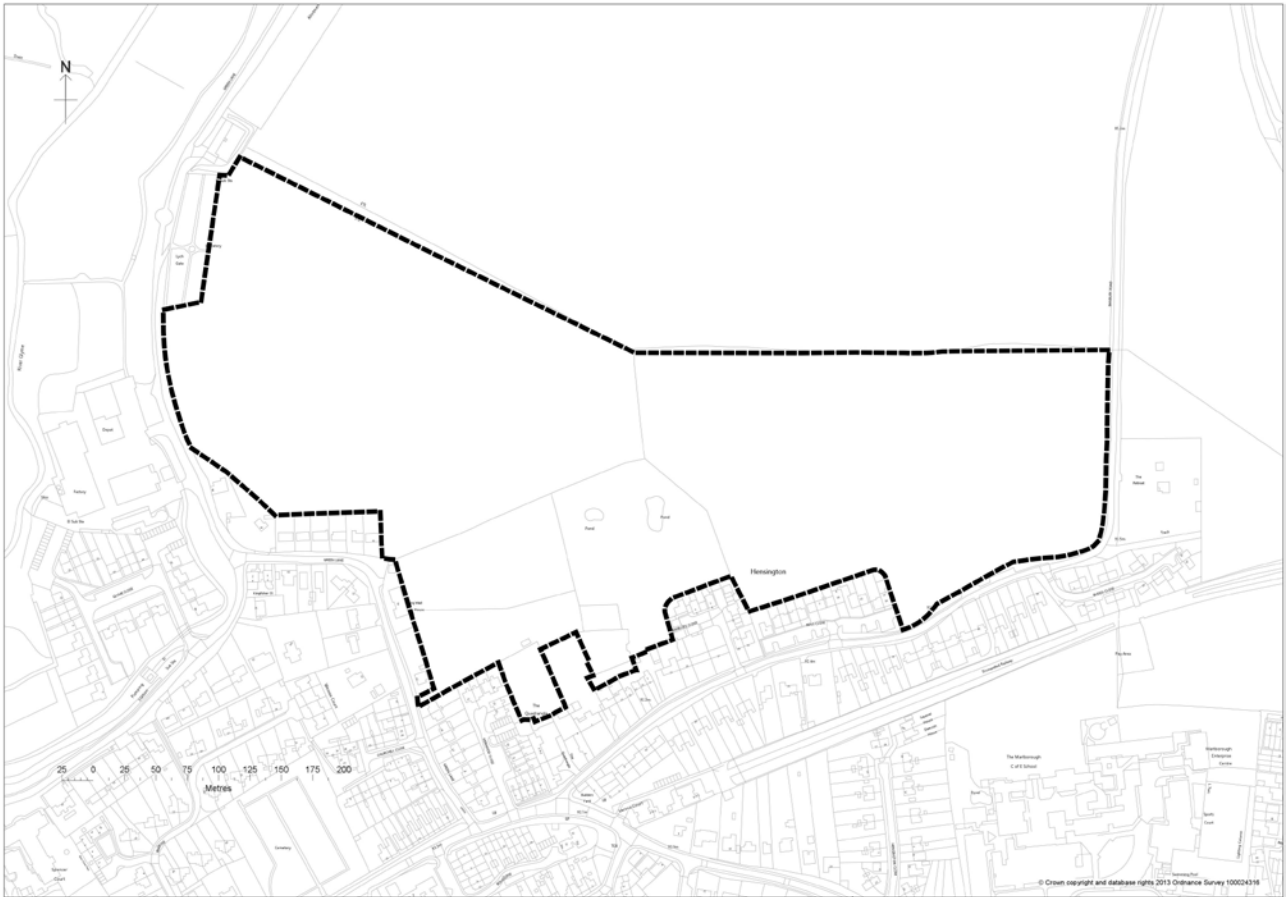


Fig 9.15f – Land at Myrtle Farm, Long Hanborough

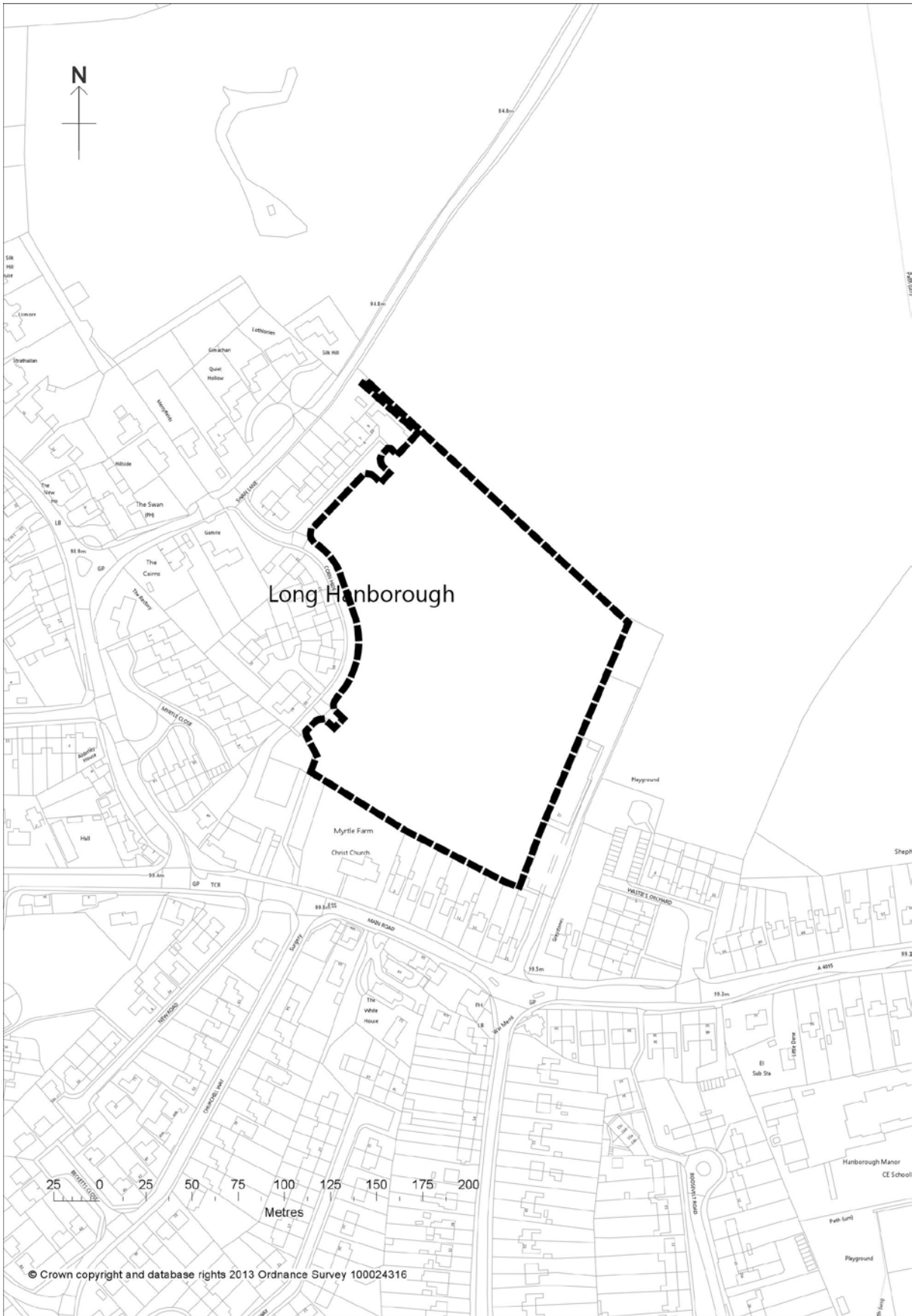


Fig 9.15g – Land at Oliver’s Garage, Long Hanborough

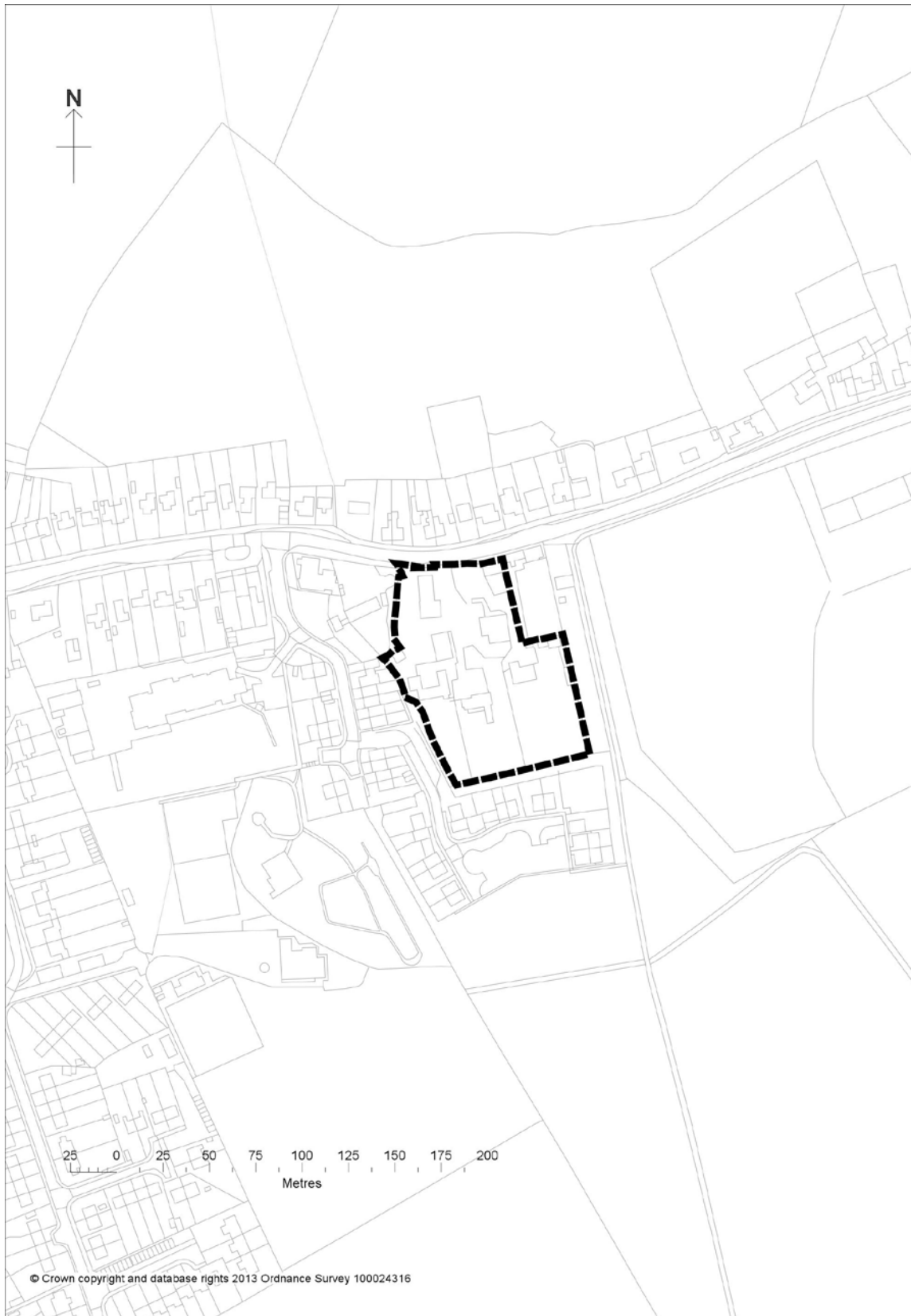


Fig 9.15h – Former Stanton Harcourt Airfield

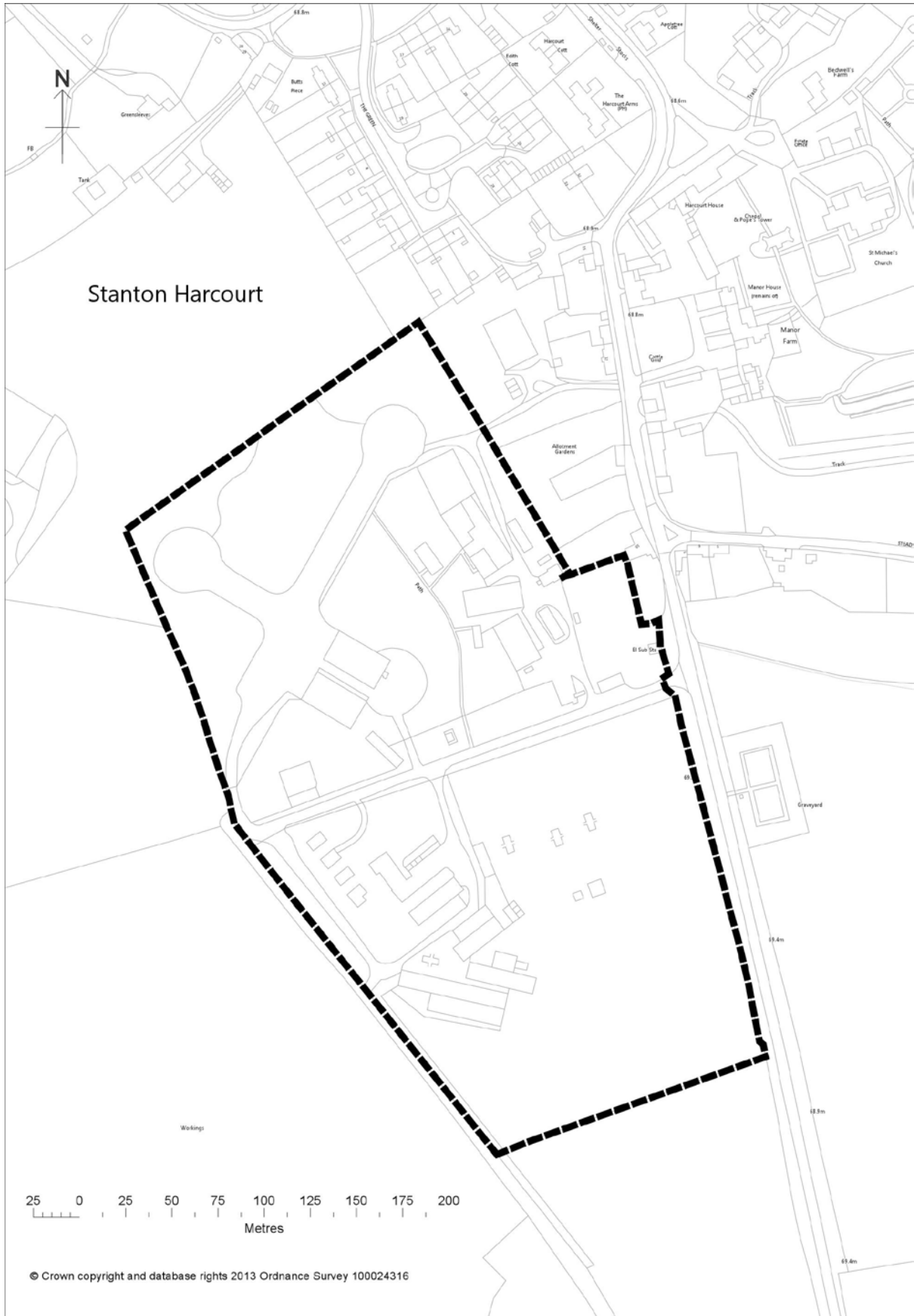


Fig 9.16 – Woodstock Town Centre

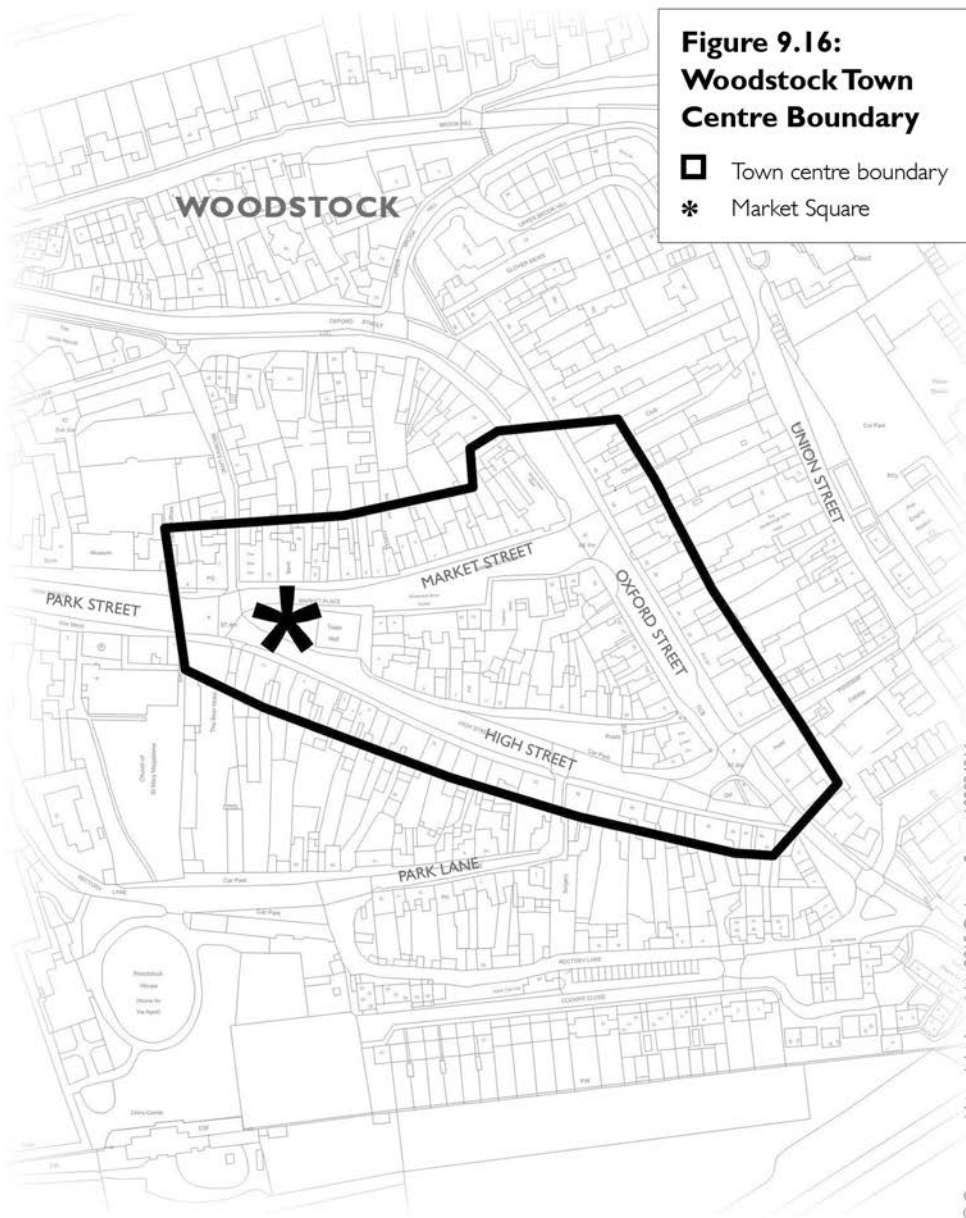


Fig 9.16a – Blenheim WHS Key Views

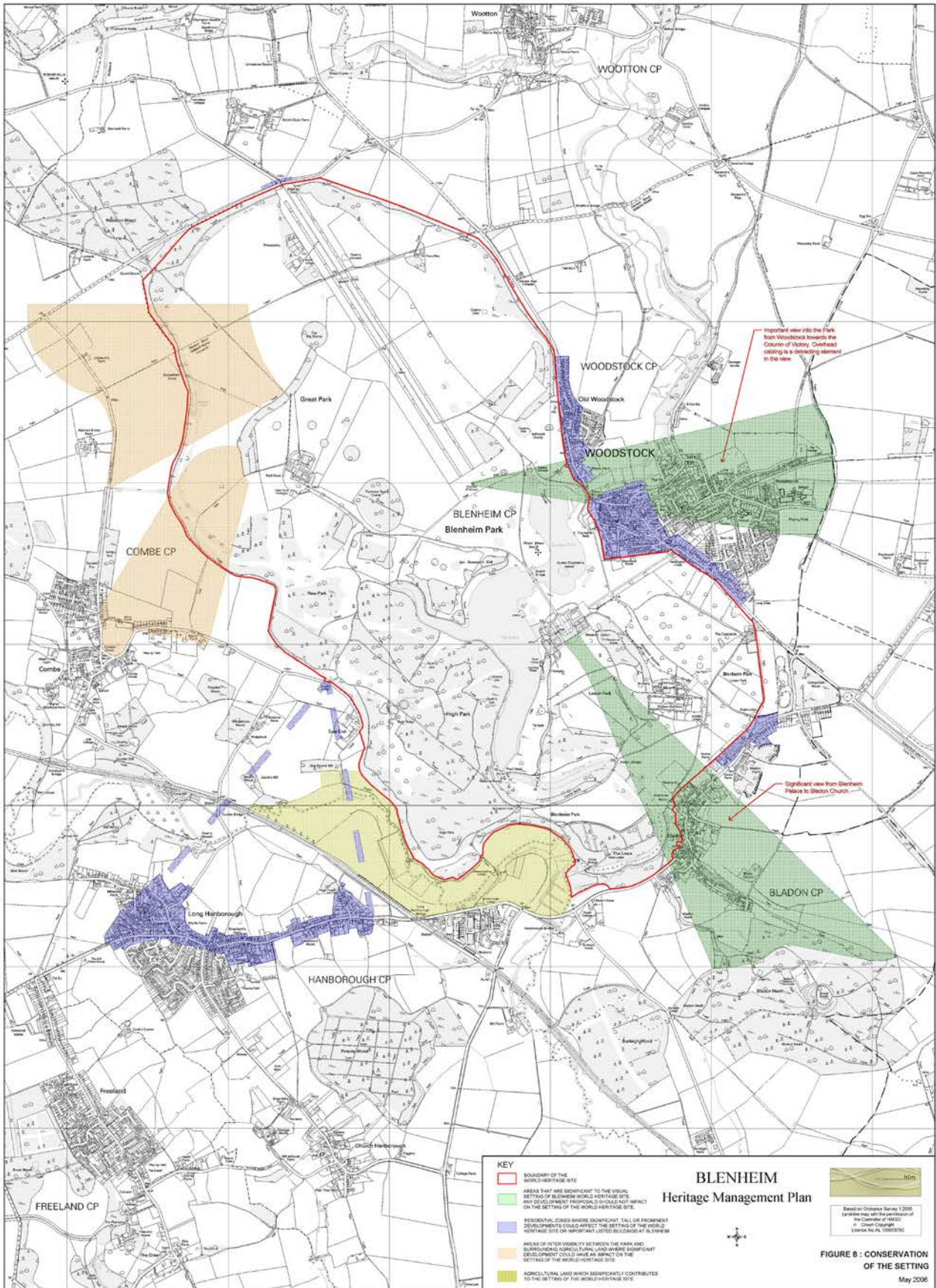
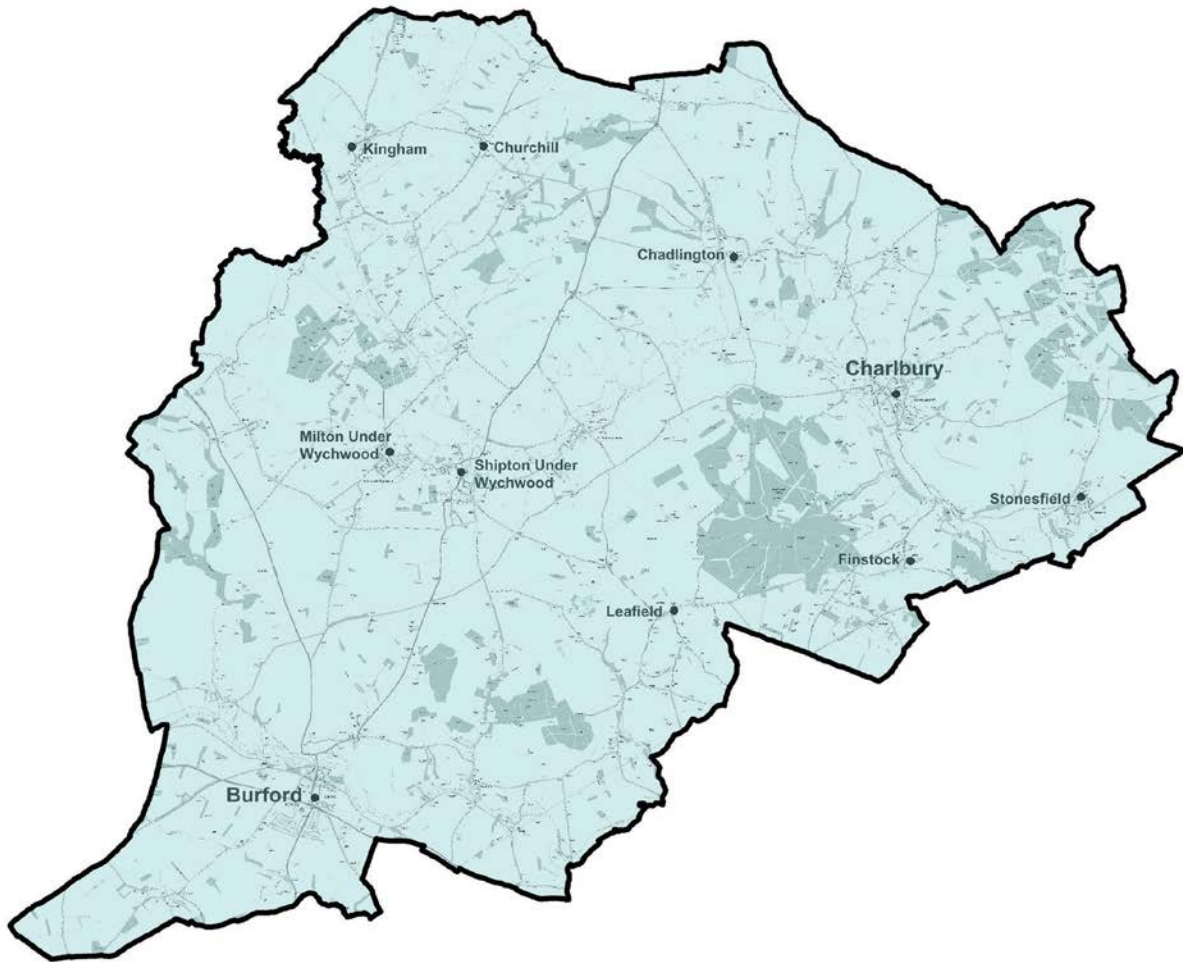


Fig 9.17 – Burford Charlbury Sub Area

Fig 9.17a – Land north of Woodstock Road, Stonesfield

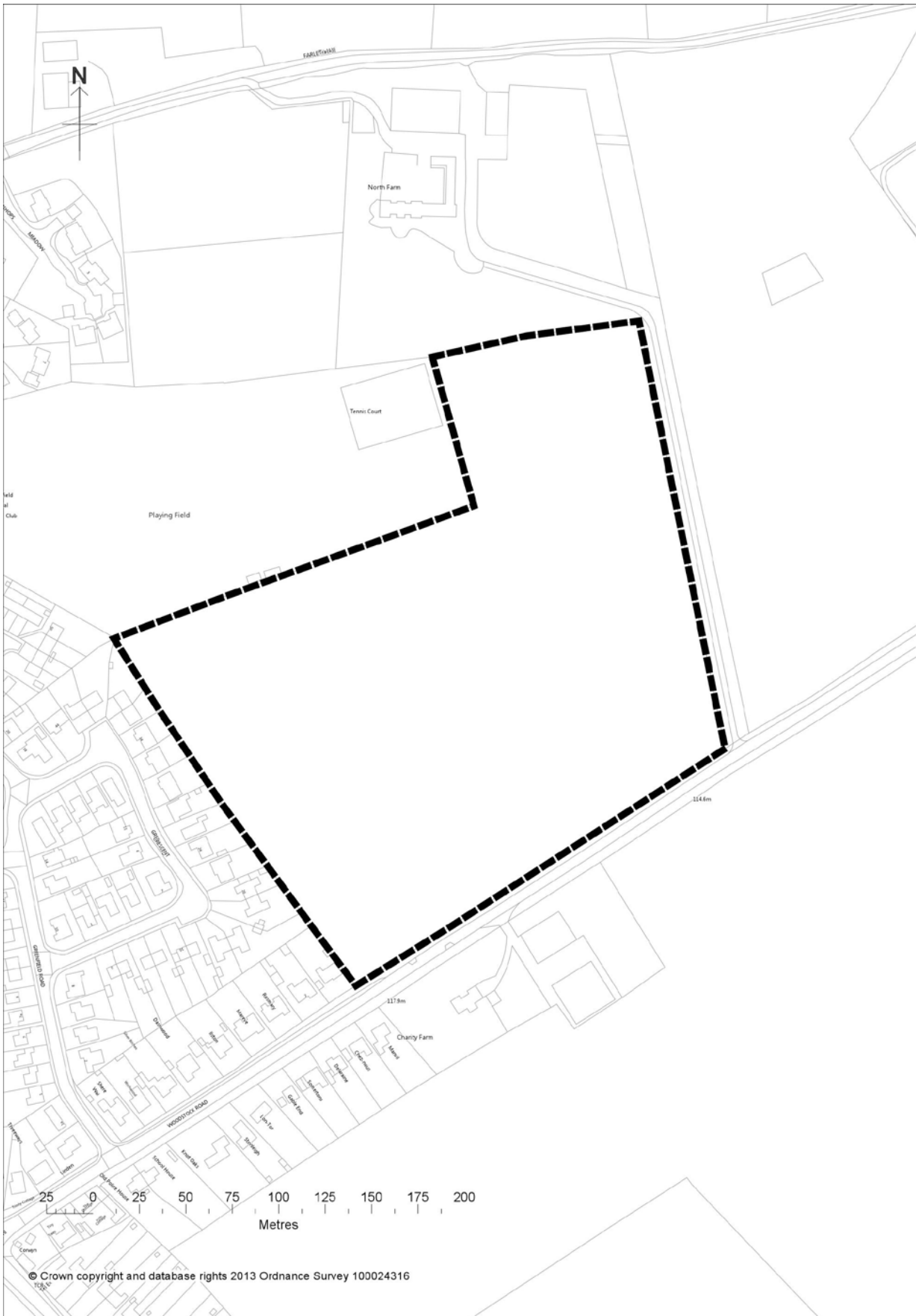


Fig 9.17b – Land East of Burford

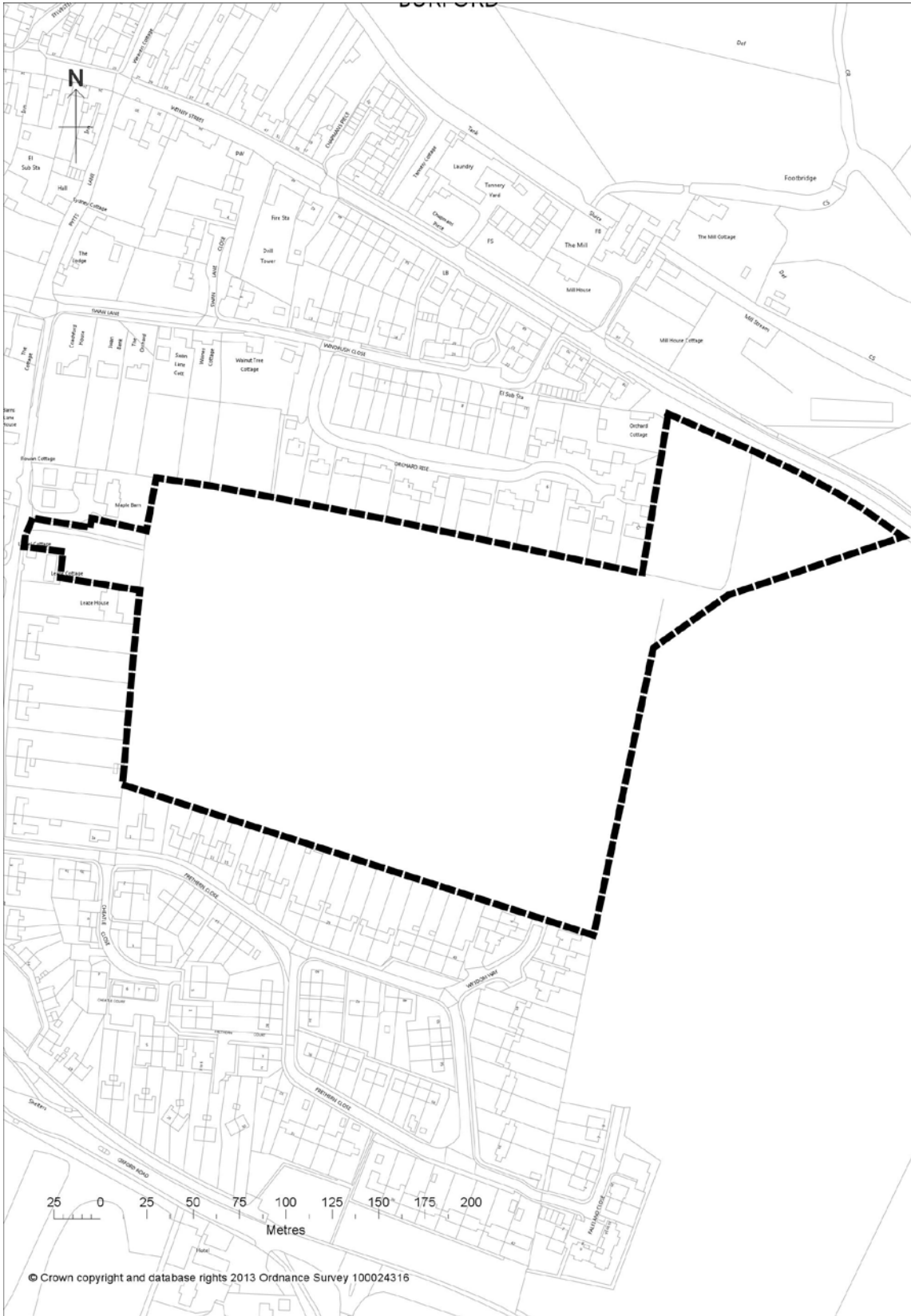


Fig 9.17d – Land south of Milton Road, Shipton-under-Wychwood

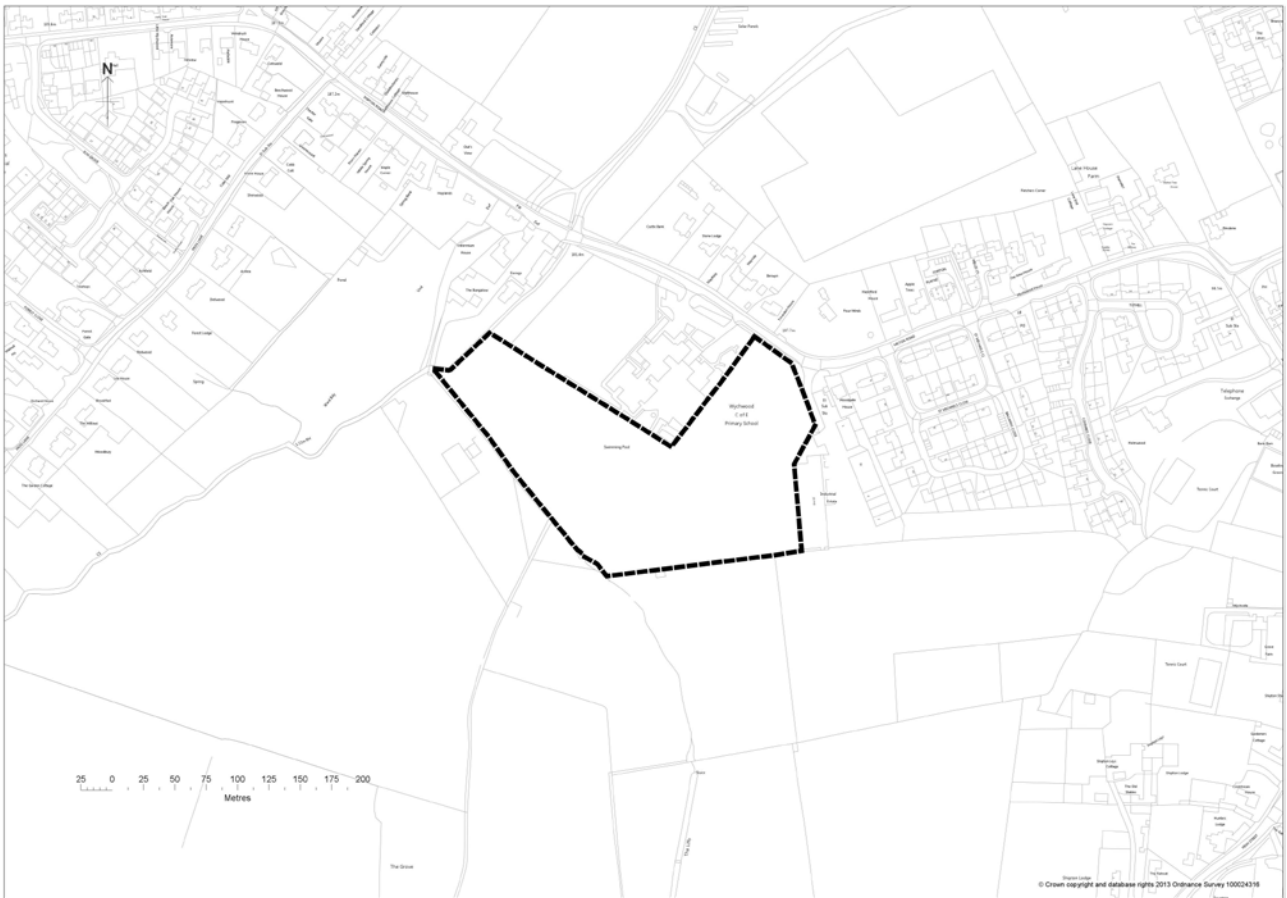


Fig 9.18 – Burford Town Centre
