I. PURPOSE

To consider and agree a programme of meetings for the civic year 2017/2018.

2. **RECOMMENDATIONS**

- (a) That the Calendar of Meetings for 2017/2018 set out in the <u>Appendix</u> to this report be approved, subject to Council's consideration of a possible change in the date of the annual meeting of the Council for 2017, as explained in paragraphs 3.4 to 3.8 below; and
- (b) That the times for the first meetings of the Overview and Scrutiny Committees after the annual meeting of the Council be as set out in the <u>Appendix</u>, but that each Committee be invited to consider the timing of its subsequent meetings during the year.

3. BACKGROUND

- 3.1. The <u>Appendix</u> to this report sets out the suggested dates for 2017/2018. The programme reflects the constitution of the Council and the fact that, as in previous years, it is not anticipated that the Development Control, Licensing and Urgency Committees will meet with any regularity, meaning that dates have not been scheduled for meetings of those Committees.
- 3.2. In addition, the transition to shared services has meant that there has been no business for the Human Resources in the current civic year to date, and it is anticipated that the Committee will not be required at all once the companies have been set up. Accordingly, no meetings of that Committee have been scheduled.
- 3.3. It should also be noted that the calendar otherwise reflects the current structures and frequencies of meetings, and that appropriate adjustments would have to be made in due course if the Council was to decide to approve changes.

Annual Meeting of the Council in 2017

- 3.4. In the years when the Council has "ordinary elections" the annual meeting of the Council has to take place within 21 days of the date when councillors retire from office; and in the year where the Council does not have ordinary elections (i.e. the year scheduled for County Council elections) it may take place on any day in March, April or May.
- 3.5. Arising from these statutory provisions, in the year of County Council elections, it has been the usual practice for the annual meeting of the Council to take place at the end of April, and when Council agreed the 2016/17 programme this time last year, it fixed both the annual and an ordinary meeting for Wednesday 26 April 2017.
- 3.6. It is now known that at least one vacancy on the Council will be filled on 4 May; and this means that the political balance calculations will be based on the numbers "in post" at the time of the annual meeting; and that there is a likelihood of needing to carry out

a further calculation and make associated changes in the membership of Committees at the next Council meeting, provisionally scheduled for 21 June.

- 3.7. Alternatively, Council could decide to (i) hold only the ordinary meeting on 26 April; and (ii) alter the date of the annual meeting to Wednesday 17 May. This would be consistent with the practice in other years, and would mean that the political balance and committee allocations could be completed at that time. However, whilst administratively preferable, I am conscious that members may have planned holidays or absences for May on the basis that there would not be a full council meeting in that month. Accordingly, the schedule in the <u>Appendix</u> retains the annual meeting as being on 26 April, but Council is invited to determine whether it would wish to change that meeting to Wednesday 17 May.
- 3.8. The Leader has indicated that in the event of the annual meeting being held on Wednesday 17 May, the Cabinet meeting scheduled to take place on that date would start at 3:15 pm, or on the conclusion of the annual meeting, whichever is the later.

Cabinet

- 3.9. As in 2016/2017, Cabinet meetings have been scheduled monthly.
- 3.10. It should be clarified that although Cabinet meetings are included in the attached programme for ease of reference, it is entirely a matter for the Leader as to the dates, timings and frequency of its meetings. The requirement of the Constitution is that it shall meet at least 12 times a year.

Licensing

- 3.11. No meetings of either the Miscellaneous Licensing Sub-Committee or the Licensing Panel have been scheduled because the need for meetings is uncertain and, in each case, meetings will continue to be arranged as necessary. This continues what has been the established practice. The experience has been that it has not been difficult to arrange Sub-Committees and Panels when needed and therefore no change in this approach has been proposed.
- 3.12. As mentioned above, meetings of the Licensing Committee have again not been scheduled. Accordingly should a meeting be necessary then the Chairman will be asked to agree a date, just as currently happens with the Development Control and Urgency Committees.

Overview and Scrutiny

3.13. In relation to the Overview and Scrutiny Committees the draft programme reflects the current start time for meetings, and these times are recommended for the first meetings after the annual meeting of Council. However each Committee will need to consider their start time for the remainder of 2017/2018.

Area Planning Sub-Committees

- 3.14. Generally, the Programme in the <u>Appendix</u> continues with the practice of scheduling Uplands and Lowlands meeting on the first and second Monday of the month, respectively.
- 3.15. However, Bank Holidays, and the May elections followed by the hiatus pending the annual meeting of the Council in May 2018 mean that this has to be varied on occasion.

4. ALTERNATIVES/OPTIONS

The Council may choose to vary any of the recommended dates shown in the <u>Appendix</u>, with the exception of those for Cabinet.

5. FINANCIAL IMPLICATIONS

This report has no financial implications.

6. REASONS

The meetings programme is proposed for adoption as good administrative practice and to ensure that the Council meetings structure is in place for 2017/2018.
