1. PURPOSE

To provide information on the Council's performance as at the end of Quarter 2, 2015/16.

2. RECOMMENDATIONS

3. BACKGROUND

- 3.1 The Appendix to this report provides detailed performance information as at the end of Quarter 2 2015/16 for performance indicators relating to Public Protection, Housing Support, Planning and Strategic Housing, Leisure and Communities and Legal and Property Services.
- 3.2 Analysis of the results has highlighted that the Council's overall performance for these services remains good.
- 3.3 There are 14 Performance Indicators relating to the work of this Committee and of these 12 are reported quarterly with targets set, one reports quarterly but has no target set and one reports annually.
- 3.4 Reported performance indicates that nine (75%) achieved target (Green), and three (25%) missed target (Red). The underperforming indicators are considered in more detail below:

Red Indicator - Missed target

PL1 - Percentage of planning applications as measured against target for 'major' application type

Target: 70%

Actual: 48.15%

This Quarter, 13 out of 27 applications were dealt with on time. Many of the applications which failed to meet the target were subject to Legal Agreements and therefore delayed whilst these were being negotiated.

PL4 - Percentage of full plans checked within 21 calendar days of receipt

Target: 80%

Actual: 26.26%

Difficulties were experienced during the summer with staffing levels and annual leave. In addition there were pressures on the admin support which slowed the throughput of applications. A new member of staff has now been recruited and it is anticipated that the figures for the next quarter will be much improved.

PL6 Number of Affordable Houses delivered (gross)

Target: 53

Actual: 44

Nine units expected to be completed this Quarter will not now be completed until Quarter 3.
