1. BACKGROUND

At its last meeting, in response to a request from Councillor Graham, the Committee agreed to include the Care Quality Commission's Report on Oxford and Banbury Hospitals within the Work Programme.

2. MAIN POINTS

- 2.1.** The Care Quality Commission is an executive non-departmental public body of the Department of Health and Social Care and acts as the independent regulator of all health and social care services in England. The Commission monitors, inspects and regulates hospitals, care homes, GP surgeries, dental practices and other care services to make sure they meet fundamental standards of quality and safety.
- 2.2.** The Commission carried out an inspection of the services provided by the Oxford University Hospitals NHS Trust between 19 to 21 November, 7 December 2018 and 8 to 10 January 2019.
- 2.3.** The Commission's report was published on 7 June 2019 and a summary of its findings is attached as Annex A. The summary outlines the outcome of the inspection, identifies areas for improvement and sets out the action the Commission has taken.
