I. PURPOSE

To provide an update on the delivery of the West Oxfordshire District Council (WODC) Low Carbon and Environmental Plan.

2. RECOMMENDATION

That the report be noted.

3. BACKGROUND

- 3.1. WODC Low Carbon and Environmental Plan is a public facing document detailing actions the Council will undertake to reduce carbon emissions and protect the environment.
- 3.2. The Plan was approved by the Environment Overview and Scrutiny Committee on 30 January 2014 and by Cabinet on 12 February 2014. It was published on WODC's website in February 2014.
- 3.3. An internal Low Carbon Action Plan was developed to take forward the aims of the Plan.
- 3.4. Completed internal actions include developing a business case on behalf of Property Services to replace the lighting at Woodgreen with more efficient LED lights. The installation of solar PV panels on the roof of Carterton Leisure Centre was completed in March 2016. In addition the viability of installing solar PV panels on the roof of Woodgreen has been explored; an initial desktop assessment has been completed with a more detailed survey now required.
- 3.5. Technical expertise on the reduction on carbon emissions has been provided into the development of the new leisure contract to ensure energy and environmental issues are taken into consideration by the new contractors.
- 3.6. External actions have focused on promoting energy efficiency to local residents via the Oxfordshire Affordable Warmth Network (AWN). The AWN, managed by the National Energy Foundation (NEF) runs the helpline and provides energy advice to residents across the county.
- 3.7. NEF secured Government funding to provide financial assistance and grants for the installation of energy efficiency measures. The Green Deal Communities Fund initially promoted grants for Solid Wall Insulation (SWI) targeted at residents in Chipping Norton. The funding was extended to March 2016 with an additional fuel poverty element providing grants to low income households in receipt of certain benefits for a wider range of energy efficiency measures. This has resulted in 25 formal offers of grants to West Oxfordshire residents which has leveraged in £72,201 worth of funding.

NEF is also working with British Gas Energy Trust promoting their boiler replacement scheme.

- 3.8. Finally, NEF is managing the Better Housing, Better Health project which will run until December 2016. This project is working with health professionals across Oxfordshire and Buckinghamshire to refer patients with medical conditions exacerbated by being in cold homes for energy advice and grants to install measures.
- 3.9. WODC's thermal imaging camera continues to be loaned out to community groups to conduct thermal imaging surveys of residents' homes. Also WODC provided winter survival packs to low income families via local food banks. The actions above also support the delivery of WODC's HECA (Home Energy Conservation Act) strategy
- 3.10. Green Homes Together (GHT), the CIC developed to deliver Green Deal to residents closed in the summer 2015. GHT was no longer a viable business when Government policy changes led to the end of Green Deal.
- 3.11. WODC is supporting the Oxfordshire Your Green Future event in the autumn. This event is promoting careers in sustainability, renewable energy and technology to school children across the county.
- 3.12. The action plan will be updated to reflect new Oxfordshire Climate Local commitments for 2016/17.
