Dear Sir/Madam,

I am writing to register my objection to the application for a premises license by Leah Horwood at 135 Burwell Drive, Witney, OX28 5LP. The basis for this opposition is that granting a license for these premises will not promote the licensing objectives, particularly the prevention of crime, disorder and antisocial behavior. Further reasons have been listed below:

1. The prevention of crime and disorder
2. Public safety
3. The prevention of public nuisance
4. The protection of children from harm

Granting a license would provide a further source of alcohol within an area already so heavily populated with licensed premises that crime, disorder and public nuisance have already reached problem levels for the local police.

Residents in this area already suffer noise nuisance and antisocial behavior at all hours of the day and night. They have endured this inconvenience since 2003 when the licensing legislation was first amended, and it is totally unacceptable to expect them to continue to do so.

In view of the above, and the enclosed petition, I would urge the Licensing Authority to refuse the application.

I write in reference to the above and wish to give formal notice of my objection to the application for the reasons outlined under the sub headings below:

**Protection of children from harm**

I note the close proximity of Queen Emma's Dyke primary school to the Premises, you will no doubt understand, that a shop selling alcohol to late at night in such close proximity to the primary school is not of any benefit to the local community nor is it safe considering that children regularly play around the Burwell shops area.

***Prevention of crime and disorder, public safety, prevention of public nuisance***

As you may or may not be aware, the Burwell shops area has had its fair share of unfavorable incidents, and in many cases, alcohol has been a contributing factor. Therefore, it is likely that a culture of late night drinking may develop to the detriment of the quality of life of local residents.
