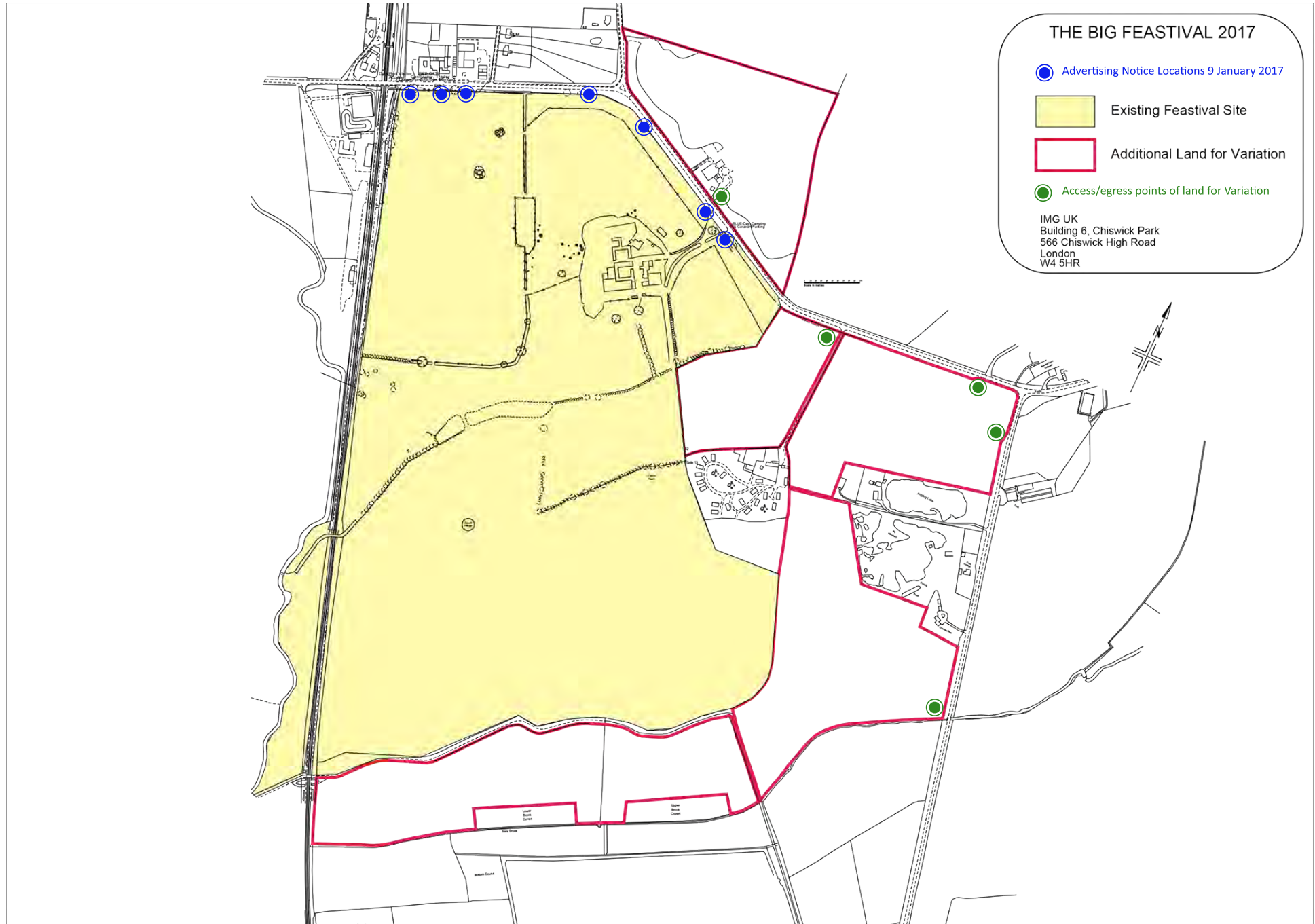
Thank you for forwarding a copy of your letter of objection which the councillors considered to be very thorough.
