#### I. PURPOSE

To have regard to the updated advice of Oxfordshire County Council as regards the secondary education contribution in connection with this application as set out in section 3 below.

### 2. **RECOMMENDATIONS**

#### 3. BACKGROUND

- 3.1. When the sub-Committee resolved to approve the application at the meeting on 9<sup>th</sup> January 2017 this included an intention to seek a secondary education contribution of £215,582.00 towards expansion of Bartholomew School, Eynsham. However, due to the pooling restrictions contained within R123 of the Community Infrastructure Levy Regulations and the need to reserve the County Council's ability to secure contributions from larger developments in the future, OCC no longer wishes to pursue a secondary contribution from this application.
