23. PARTICIPATION OF THE PUBLIC

There was no public participation.

24. <u>INTRODUCTION OF DRIVER ASSESSMENT FOR HACKNEY AND PRIVATE</u> <u>HIRE DRIVERS AND CANDIDATES</u>

The Sub-Committee received the report of the Shared Head of Public Protection seeking the introduction of a driver assessment for new and existing hackney carriage and private hire drivers as an alternative to the Driver and Vehicle Standards Agency (DVSA) Taxi and Private Hire drivers test.

The Principal Community Safety and Licensing Officer introduced the report and explained that a number of operators had asked for consideration of a local assessment test. It was clarified that the proposed assessment would cover the same areas as the DVSA test but instruction could also be given to rectify any issues.

The Principal Community Safety and Licensing Officer advised that the cost would be less than the DVSA test and they would be available in the evening and at weekends. It was confirmed that drivers could still take the DVSA test if they preferred. Members were advised that the new test would only be recognised in West Oxfordshire whilst the DVSA qualification was transferrable.

Mr MacRae in supporting the new test highlighted that it was positive the council was working in liaison with the trade on this matter. The Principal Community Safety

and Licensing Officer further highlighted that it was positive for local businesses that would provide the assessments.

Mr Saul suggested that the new assessment appeared to be more comprehensive and it was positive that advice and training could also be provided to drivers.

RESOLVED: That, the sub-committee approves the introduction of a driver assessment as an alternative to the DVSA Taxi and Private Hire drivers test.
