40. REVIEW OF STREET TRADING CONTROLS IN WEST OXFORDSHIRE

In response to a question from Mr Good, the Licensing Officer advised that discussions had been held with the owner of the catering unit referred to at paragraph 3.4 of the report and alternative locations in the Market Square on non-market days and Welch Way on Thursdays and Saturdays identified.

RESOLVED:

- (a) That notice be given in accordance with Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982 that, with effect from 1 May 2015, the following streets or areas if there are no street names, attached as Appendix A, be designated as prohibited streets (in addition to the prohibited streets already designated by the Council) including all forecourts, roads, footways or other areas adjacent to the streets referred to in this resolution for a

distance of 10 metres from the edge of the adopted highway and that the following street, attached as Appendix B be designated as a consent street (in addition to the consent streets already designated by the Council).

- (b) That the revised Street Trading policy 2015 attached as Appendix C to the report, amended as detailed above, be approved.
