Berkshire, Buckingham and Oxfordshire Wildlife Trust made the following comments regarding the application:

As you are aware BBOWT issued a holding objection to the previous application for a 30 unit scheme on this site (app.15/01937/OUT). This was based on three main issues: 1) a lack of survey information for protected species, 2) a lack of assessment of impacts on Local Wildlife Sites (LWS) and 3) No provision for ongoing management within the Conservation Target Area (CTA).

Having reviewed the information relating to the current application BBOWT no longer wishes to object to the scheme subject to appropriate conditions, management and funding requests put forward by the in-house ecologist being adhered to. Main reasons for this are the submission of acceptable protected and notable species information, the significant reduction of the scheme to ten units, the concentration of the built-form further away from the stream corridors and therefore the Local Wildlife Sites (LWS) and the retention and management of the eastern more valuable habitats, latter of which present a good opportunity to work in line with the aims of the CTA as well as providing an effective buffer between the development and the Enstone Meadow LWS.

I note that the Council's in-house ecologist has provided comprehensive comments on the scheme including appropriately worded conditions. She also stresses the need for appropriate management and funding to be secured prior to planning consent. I endorse her comments and approach to this scheme
