FOOTPATH No. 156/6(PART)

PUBLIC PATH DIVERSION ORDER 2018
TOWN AND COUNTRY PLANNING ACT 1990 SECTION 257

THIS ORDER is made by West Oxfordshire District Council under section 257 of the Town and Country Planning Act 1990 (as amended) because it is satisfied that it is necessary to stop up the section of footpath to which this Order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely the development of a new extension to the existing sports pavilion granted planning permission under application reference 17/02331/FUL.

BY THIS ORDER:

- 1 The footpath over the land shown by a bold black continuous line on the plan contained in this Order (“the Order Plan”) and described in Part 1 of the Schedule to this Order (“the Schedule”) shall be diverted as provided below.
- 2 There shall be created to the reasonable satisfaction of Oxfordshire County Council an alternative footpath for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by a bold black broken line on the Order Plan.
- 3 The diversion of the footpath shall have effect on the date on which Oxfordshire County Council certify that the terms of Article 2 have been complied with.
- 4 Where immediately before the date on which the footpath is diverted up there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying out their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

SCHEDULE

PART I

Description of existing path or way

The entire width of that length of Footpath No. 156/6 on the Definitive Map for the Parish of Charlbury that runs from OS Grid Ref SP 3578 1971 (Point A on the Order Plan) in a south-westerly direction for approximately 35 metres to OS Grid Ref SP 3575 1969 (Point B on the Order Plan) then in a north-westerly direction for approximately 12 metres to OS Grid Ref SP 3575 1969 (Point C on the Order Plan) as shown on the Order Plan annexed hereto by a bold black continuous line between Points A-B-C.

PART 2

Description of new path or way

The alternative route proposed commences at OS Grid Ref SP 3578 1971 (Point A on the Order Plan) and extends in a westerly direction for approximately 24 metres to OS Grid Ref SP 3576 1970 (Point D on the Order Plan) then in a south-westerly direction for approximately 14 metres to OS Grid Ref SP 3575 1969 (Point C on the Order Plan) to re-join the unaffected route of the existing Footpath No. 156/6 as shown on the Order Plan annexed hereto by a bold dashed line between Points A-D-C.

The width of the proposed new route is 2 metres.
