Executive Response to Recommendations from Overview and Scrutiny Committee on Nature Recovery Plan and Nature Recovery Officer.

Recommendations arising from the Overview and Scrutiny Committee meeting on Wednesday 7 February 2024.

Context

The Overview and Scrutiny Committee noted that more rural areas of the district could be disadvantaged, as opposed to more urban areas regarding the financial provision for an additional financial pot for finding nature recovery projects in rural areas that would struggle to provide match funding through WestHive.

3. That consideration is given to the need for an additional financial pot for funding nature recovery projects in rural areas that would struggle to provide match funding through WestHive.	N	<p>Alongside the WestHive Community Crowdfunding Fund, which the Council can pledge up to £10,000, or a maximum of up to 40% of the project target, there is also the Community Infrastructure Fund for capital projects (part of the Rural England Prosperity Fund). Eligible projects for this fund can expect a pledge from the Council of up to £20,000 of capital or a maximum of up to 50% of the crowdfunding target.</p> <p>Nature recovery is an explicit outcome of both funds; therefore an eligible project could apply to both and potentially receive pledges up to £30,000 to a maximum of 90% of the project target.</p> <p>In addition, 3-year service level agreement grant funding, starting from April 2024, will be awarded to successful applicants shortly, as a key decision.
