West Oxfordshire District Council is committed to supporting local farmers and food producers across our district. Britain has some of the highest animal welfare standards in the world, and WODC will continue toshould engage and work in partnership with poultry, arable and livestock farmers, and with horticulturalists and agroecologists, to ensure they can continue to enhance our countryside, and contribute to our nation's food security, protect and enhance biodiversity and improve our soils.
