Public comments:

Three additional objections letters have been received since the officer's report was drafted. These are available to view online. The key points raised are:

- The additional documents do not change the objections previously made to the application;
- The development will still be harmful to the character of the area, the local community and the infrastructure supporting it;
- Object even more strongly now as the surface water drainage strategy is fundamentally flawed.

Environmental Protection (Air Quality):

The Council's Environmental Protection Officer (Air Quality) has also provided the wording for the recommended conditions referred to in the officer's report as follows:

Pedestrian Footpaths

Prior to the occupation of the hereby approved planning application, the proposed footpath between the development and The Bartons Memorial Sports & Social Club, shall be constructed and be in full operation, allowing pedestrian access to the facility as well as access to bus stops on Worton Road.

REASON: West Oxfordshire District Council is committed to supporting measures that will reduce emissions from transport and is keen to promote the uptake active travel. The inclusion of this footpath will facilitate this.

Electric Bike Hub

Prior to the erection of the development hereby approved, written and illustrative details of the electric bike hubs shall be submitted to the local authority, including details of how these facilities will continue to be maintained following full occupancy of the development. The electric bike hubs shall be installed within twelve months of the first occupancy.

REASON: West Oxfordshire District Council is committed to supporting measures that will reduce emissions from transport and is keen to promote the uptake active travel. The incorporation of ebike hubs will facilitate this.

It was also confirmed that a condition for EV parking spaces was not necessary as this is now required by Building Regulations.

One further objection letter has been received by a member of the public as follows:

I strongly object to this application for the following reasons.

The site proposed is not in a suitable position regarding entry and exit at a what is already a busy junction. I live in Gagingwell just a short distance along the B4030 from the site. This road although only a B road is the only road from the A44 to Bicester which is becoming increasingly built up. So with all the traffic going to Bicester and locally to and from Enstone Airfield Industrial Estate and the Whiteways Technical Centre (i.e. Alpine racing) the road just can't cope. HGV's now have loads in excess of 40 tons whereas when the road was built many years ago the loads were much less and the traffic much lighter. Any extra burden on these roads is just not acceptable.
